Report on International Conference on Climate Change March 09-10, 2019





The Centre for Environmental Law, Advocacy and Research (CELAR), a research centre of National Law University and Judicial Academy, Assam, organized a two-day International Conference on Climate Change on 9th and 10th March 2019. It was co-sponsored by the prestigious Shastri Programme Development Grant (SPDG) of the binational Shastri Indo-Canadian Institute, New Delhi. The focal area of the Conference was to explore the multidisciplinary contours of climate change. As such, the conference witnessed the presentation of research made by seventy select people across various academic disciplines, like law, economics, technology, geography, sociology, business, commerce and technology. It also witnessed the scholarly presence of over fifty delegates. The participants hailed from Assam and other places across the length and breadth of India as well as from several foreign countries like Bhutan, Nepal, Bangladesh and Mexico.

The Conference dwelled on three primary themes namely, the international dimension on climate change, focussing specially on the Indo-Canadian dimension and the national and north east Indian dimension on climate change. To stimulate discussions and debates, eminent personalities and experts in each of the thematic dimensions were present. The luminaries included judges like Chief Justice A.S. Bopanna, Justice S. Shyam and Justice U. Bhuyan of Gauhati High Court, Justice P.M.M. Peires, former Chief Justice of the Supreme Court of Sri Lanka and Dr. Ranjan Chatterjee from the National Green Tribunal. It also included lawyers like Mr. Sanjay Upadhay and Mr. Sudhir Mishra of the Supreme Court of India, academicians like Prof. (Dr.) Armin Rosencraz from Stanford University, Prof. (Dr.) Phillip Cullet from SOAS University of London, Prof. (Dr.) M.K. Ramesh from NSLIU, Prof. (Dr.) Chandan Mahanta from IIT-G and activists like Ms. Rama Rauta, Pioneer of the Save Ganga Movement, Mr. JadavPayeng, the Forest Man of India and Mr. Rajendra Singh, the Waterman of India. Led by such personalities, the technical sessions of the Conference witness some intense deliberations on how best to combat climate change, especially the peculiar climate vulnerabilities of Assam and North East India.



Report on Two Day Seminar on Traditional Knowledge and Cultural Expressions May 03-04, 2019

The Centre for Advanced Research on Intellectual Property Rights (CARIP), a research centre of National Law University and Judicial Academy, Assam, organised a two day Seminar on Effective Protection of Traditional Knowledge and Cultural Expressions and Community Experiences in collaboration with North East Centre, New Delhi on May 03-04, 2019. The seminar was sponsored by Indian Council for Social Science Research (ICSSR). The inaugural session was attended by Shri Siddhartha Bhattacharyya the Hon'ble Education Minister, GDD and Law & Justice as the Chief Guest. He congratulated the University for taking up an important issue of traditional knowledge and its protection and expressed his appreciation for the infrastructure of the University and promised to help the latter with any kind of assistance from his end. The Chairman, APSC Shri Deepak Sharma and Dr. S.B. Medhi Retd IAS, Chief Executive, Assam Human Rights Commission were the guests of honour. The seminar was spearheaded by Centre for Advanced Research on Intellectual Property Right (CARIP) of NLUJAA in association with North East Centre, Delhi. The key resource persons were Padmasree P. Pushpangadan, Director General at Amity Institute for Herbal and Biotech Products Development, Prof TC James, NIPO, Delhi, Ms. Ghazala Javed, Ministry of AYUSH, Govt. of India and representative of National Biodiversity Authority and State Biodiversity Board of Assam, Director, NIRD, Prof. Chandan Mahanta from IIT Guwahati, Prof. P.C. Bhattacharyya, Trustee and Vice-Chairman, Wild Life Trust of India and many other eminent people in the area of Traditional Knowledge (TK) and Intellectual Property Right (IPR) graced the two day brainstorming session. The main objective of the seminar was to highlight the legal and other challenges in the area of traditional knowledge and cultural expressions and the growing impact of IPR in this area and its significance. For giving a practical dimension to the seminar real time TK practitioners from north east i.e. Assam, Arunachal Pradesh, Nagaland and Sikkim were invited to share their perspectives. The paper presenters were mainly academicians and research scholars from all parts of India. The book on conference proceedings titled Traditional Knowledge and Traditional Cultural Expressions and Community Perspectives published by NLUJAA with ISBN was released on the inaugural day. The main highlight of the two day seminar was the showcasing of two documentaries on traditional silk making of Sualkuchi and traditional bell metal industry of Sarthebari made by CARIP depicting the historical origin and significance of these TK based industries and problems faced by the artisans and weavers especially the aspiration of the people of Sarthebari to obtain a geographical indication mark for the bell metal. The Valedictory session was graced by Hon'ble Justice A.K. Goswami, Judge Gauhati High Court as the Chief Guest and Dr. Arup Kumar Mishra, Director, Assam Science, Technology and Environmental Council as the guest of honour.





The Director, ASTEC promised to help the people of Sarthebari in getting GI for their traditional bell metal. Hon'ble Justice A.K. Goswami hailed the topic of the seminar as very pertinent and much needed. The Hon'ble Vice- Chancellor Prof. J.S. Patil while thanking the august gathering expressed that the University would work together with govt agencies like ASTEC, NGOs, institutions and directly with communities in legal issues of IPR and capacity building in matters of TK and TCEs. The two day seminar also had exhibitions of silk handloom by Assam textile and handloom department, Assam Co-operative Bell Metal Utensil Manufacturing Society Ltd, Sarthebari and Rural and Tribal Development foundation, Sualkuchi Muga Farm. The key outcome of the seminar can be summed up as urgent need to give a new policy and economic push to preserve the traditional knowledge based rural industries, need for awareness and capacity building, need for modern technology to make the traditional industry compete with the mechanised industry, to give recognition to cultural IP right of the communities over their age old TK, effective use of IPR to grant legal protection to cultural expressions of indigenous communities and need for sui generis Law and policies besides adequate financial and other assistance from the government in a holistic way.

Regional Consultation on Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013 February 16, 2019

Regional Consultation on Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013 organised by National Commission for Women in collaboration with Centre for Gender Justice, NLUJAA on February 16, 2019. This exercise is a flagship of the National Commission for Women (NCW) and through the collaboration the intent has been to create a forum where representatives from the eight states of North East India could lend their inputs towards reviewing the POSH (Prevention of Sexual Harassment) Act; mulling the pros and cons of the provisions of the Act and in light of the same proposing recommendations towards enhanced protection of the rights of women at workplace.



The POSH Act is an important milestone towards ensuring prevention, prohibition and redressal of harassment of women in their workplaces. However, six years since it has become a statute, it is about time a seasoned critique of the provisions of the Act is undertaken. In this pursuit, resource persons and consultants from all over the region have lent their support. Academicians, administrators, activists, legal professionals from the NE Region have contributed their insights towards reviewing and improvising the scope and applicability of the existing POSH Act. NCW Member, Ms. Soso Shaiza and Chief Programme Coordinator Ms. Lilabati were present during the consultative exercise.

1st Vox Anatolis National Moot Court Competition, 2019 March 01-03, 2019

The 1st Vox Anatolis National Moot Court Competition, 2019 took place on 1st-3rd March, 2019. This was the 4th National Moot Court Competition organised by National Law University and Judicial Academy, Assam. 1st Vox Anatolis National Moot Court Competition, 2019 is first of a kind since it's the first National Moot Court Competition in the country which was based on the legal issues concerning a particular region, in this case the North East. A total of 43 teams had provisionally registered for the competition out of which only 26 teams were allowed to take part in the competition. The inauguration ceremony took place on 1st March, 2019 in the University Seminar Hall and it was graced by Hon'ble Justice (Retd.) B.P. Katakey. The Semi-Finals and the Final Rounds took place on 3rd March, 2019. Distinguished lawyers of the Guwahati High Court and Advocate Surajit Dutta, B.C. Kayel, Rajeev Baruah, S C Biswas, Haisbur Rahman and B C Das along with Hon'ble Mr. Justice Ujjal Bhuyan of Gauhati High Court presided as judges in the Semi Finals and Final Rounds of the competition. The team representing School of Excellence in Law, Christ University won the 1st VoxAnatolis National Moot Court Competition. While the team representing School of Excellence in Law, Ambedkar University became the runner's up. Mr. Ritu Raj of Maharashtra National Law University, Nagpur won the Best Researcher Award. While the team representing Maharashtra National Law University, Mumbai won the best memorial award. Mr. Rohan Pratap Singh of National Academy of Legal Studies and Research, Hyderabad won the Best Counsel award.


Workshop on Due Diligence and Corporate Legal Drafting November 16, 2019








Legal Awareness Camp November 23, 2019




Celebrated 70th National Constitution day November 26, 2019




Title: Journal for Sports Law, Policy and Governance

Documentary Title: Sualkuchi: Manchester of Assam
Date of Publication: May, 2019

It is a documentary on Sualkuchi, the land of silk weaving. Sualkuchi, a village in the Kamrup district of Assam that has been developed over the years as a major centre for commercial production of indigenous fabrics especially the Assam Silk. Situated on the northern banks of the mighty Brahmaputra, it is famous for its centuries-old heritage of weaving. Sualkuchi is endearingly referred to as the Manchester of the East because the people of Sualkuchi are very industrious and out of their hard labour, they weave out beautiful attires of Assam silk known as the Mekhela Chadar. The Mekhela Chadar is the traditional dress worn by women in Assam. Sualkuchi has a population of nearly fifty thousand people, most of who are engaged in weaving magic on their looms. The documentary focusses mainly on the methods and processes involved in Assam silk weaving. Assam silk denotes the three major types of indigenous wild silks produced in Assam—golden muga, white paat and warm Eri silk. The documentary also covers the issues and challenges faced by the silk weaving industry of Sualkuchi. It also highlights the historical attractions of Sualkuchi such as Hati Satra, Gandhi Mandap, Ishwar Sri Sri Siddheswar Devalaya, etc. This documentary is prepared by the members of Centre for Advanced Research on Intellectual Property Rights, NLUJAA.

Documentary Title: Bell Metal Industry of Sarthebari: A Golden Treasure Date of Publication: May, 2019

The documentary titled "Bell Metal Industry of Sarthebari: A Golden Treasure" is another production of the Centre for Advanced Research on Intellectual Property Rights, NLUJAA which is based on traditional bell metal industry of Sarthebari. It highlights the processes and stages involved in making the bell metal items. Sarthebari is a town located at a distance of around 90 km to the west of Guwahati in Barpeta district of Assam. Sarthebari has occupied a distinct place in Assam because of its uniqueness of being associated with production of bell metal items which is an important craft industry and have survived for ages. The main craftsman known as "Kanhar" who inherit the skill of making bell metal items from their forefathers and under their leadership other artisans used to work in the production of bell metal items. The documentary also reflects the problems faced by the traditional bell metal industry of Sarthebari. The industry is facing a very tough competition from the cheaper quality substitute items which are replacing the original bell metal items. The Government should provide adequate support to survive this bell metal industry and protect this traditional knowledge from extinction.
