4. Vendors are requested to enclose a copy of their valid certificate of PAN No., TAN No, and Service Tax No. with their quotation.

5. Vendors may note that if the date of quotation opening given in this short quotation notice is declared to be a holiday, the quotation shall be opened on the next working day at the same timing. In such an event the closing hours for receipt of quotations in NLUJAA will stand automatically extended up to 4.00 P.M. of the next working.

6. Late/delayed quotations received in NLUJAA due to any reason whatsoever will not be accepted.

7.Vendor are at liberty to be present or authorize a representative to be present at the opening of the quotation at the time and date as specified in the Schedule. The name and address of the representative authorized to attend the opening of the quotation on behalf of a tendering firm should be indicated in the tender. The representative so deputed should also bring with him a letter of authority from the firm for having been authorized to be present at the time of opening of quotation.
