NOTICE INVITING QUOTATION

Sealed quotations affixed with non refundable Court fee stamps of Rs. 8.25 (Rupees Eight and Twenty Five paise) only are hereby invited from reputed firms/agencies/individuals for **Comprehensive Annual Maintenance Contract of Air Conditioners: w.e.f 01-04-2021 to 31-03-2022** at National Law University and Judicial Academy, Assam as per the details and terms & conditions given below, which will be received at the office of the Registrar, NLUJAA during office hours up to **05:00 PM** on or before **03-03-2021**. Quotation opening date and time will be notified in the University website www.nluassam.ac.in. The Quotationer/Tenderer or their authorized agents may remain present at the time of opening of the quotations. Tenderer are advised to view the website regularly for update.

Details of air conditioners to be placed under Annual Maintenance Contract (2021-2022) in National Law University and Judicial Academy, Assam are as follows:

Qualifying Criteria:

Minimum qualifying criteria for firm/agencies participation shall be as follows:

1. Must be registered with Govt./Semi Govt. Department/Autonomous Body/ reputed PSU for similar type of work.
2. The firm must have experience of successful execution of similar type of work of value not less than 2,50,000.00. Endorsing document must be submitted.

Scope of work:

1. AMC shall include gas charging, repair of compressor, repair/replacement of motor, repair/replacement of minor/major parts (capacitor, PCB, controller, relay, conductor etc.) excluding replacement of compressor. AMC shall include checking of refrigerant pipe for any leakage and repairing, checking machine for noise, vibration and rectification the same, cleaning of air filter/replacement of air filter, changing of lubricant oil periodically in the compressor, checking suction and discharge pressure of compressor.
2. The contractor shall have to provide services against breakdown incidents and the same has to be attended to within 24 hours.
3. The contractor shall have to undertake preventive maintenance at least once in every month other than breakdown services.
4. Any parts required for replacement shall be of the same make and specification as the existing parts.

Terms and Conditions:

1. The rates should be quoted per year basis against the work/items/articles and should be inclusive of GST/taxes applicable at any point of time as per **Annexure-A**.
2. The sealed envelope should bear the following 'superscription' on the top:
"The Registrar, National Law University and Judicial Academy, Assam".
3. The Quotationer/Tenderer will have to deposit Earnest money of **Rs. 10,000/-** in the form of Demand Draft in favour of Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of contract period.
4. **Each Firm must have GST registration, Trade License, PAN Card, Labour License, ESI & EPF Registration Certificate, Income Tax Clearance Certificate, Experience details etc. A copy of the same must be submitted along with the Quotation/Tender.**
5. The contractor shall also supply the requisite number of workmen with means and materials as well as tools, spares, appliances, machines, implements, vehicles for transportation etc. required for proper execution of work.
6. AMC will be for a period of twelve months commencing from 01.04.2021 to 31.03.2022. This contract can be cancelled unilaterally by NLUJAA whenever service is not found satisfactorily or up to the mark.

7. The rates accepted will be remain firm and fixed during the currency of contract.
8. Payment will be made on quarterly basis.
9. The ACs will be kept in working condition at all the times during currency of contract.
10. The contractor will be responsible for the safety of the manpower engaged and will not deploy any minor to work.
11. It is to be clearly understood by the contractor that the contract is purely a commercial engagement and is not an employment. There will be no employer employee relationship between National Law University and Judicial Academy, Assam and the contractor's employees. Immediately on termination of this contract, the contractor shall be obliged to withdraw all employees from the said premises of work.
12. The contractor shall be liable for any damage or compensation payable in accordance with law in respect or in consequences of any accident or injury to any workmen or other person in their employment as per the provision of the Workmen Compensation Act.
13. The AMC service provider shall maintain log book/file containing maintenance report duly countersigned by NLUJAA officials.
14. The firm will be required to undertake preventive maintenance by checking all the air conditioners at least once every month and confirm that the systems are in the best of working conditions.
15. All service request/calls for repair work must be attended to within 24 hours of the complaint being lodged with the AMC provider. There should be adequate number of telephone lines for lodging of service requests. If the AMC provider firm fails to attend call within 24 hours, NLUJAA reserves the right to get the work done by other firms and deduct such expenses from the AMC charges.
16. Merely submission of quotation does not entitle the firm to forward its claim for awarding the AMC ever if it has quoted the lowest rates. The AMC will be awarded to the eligible firm only after all the formalities as, per the terms and conditions, are complied with and valid documents are produced to the satisfaction of this office.
17. All quotations in the prescribed format should be submitted before the time and date fixed for the receipt of quotations.
18. A security deposit/Bank Guarantee for 10% of contracted value will have to be deposited by the contractor to whom the AMC is awarded before commencement of the contract as performance security. This will be refunded on successful completion of the Annual Maintenance Contract. No interest shall be paid by NLUJAA on performance security deposit. The security deposit will be forfeited if any of the condition of the contract is contravened besides any other action that may be taken against the contractor.
19. The payment to the contractor will be made by account transfer only on production of bill duly certified by NLUJAA authority and necessary deduction for tax etc. will be made as per rule.
20. On the expiry of the contract, the firm will hand over the ACs in perfect working condition after rectifying the defects etc. if any. In case of failure of the firm to comply with this condition, the University will consign the repair work to some other party and the expenses so incurred will be charged to the firm's account.
