Terms and Conditions:


1. The rates should be quoted as shown against the items/articles and should be inclusive of all GST/taxes applicable at any point of time.
2. The sealed envelope should bear the following 'superscription' on the top: 'The Registrar, National Law University and Judicial Academy, Assam'.
3. Sample of cloth (minimum 1/2 mtr.) need to be submitted with the quotation. Delivery of items should be completed within 15 (fifteen) days after receipt of supply order.
5. Quoted rate for Shirt, Pant, Saree and Blouse should be inclusive of stitching charges.
6. The Quotationer/Tenderer will have to deposit Earnest Money of Rs. 5,000/- in the form of Demand Draft favouring Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of work.
