6.4 LATE BIDS:

Any TENDER received after the deadline for submission of TENDER prescribed by the Registrar, National Law University and Judicial Academy, Assam shall be rejected and/or returned unopened to the Tenderer.



TERMS AND CONDITIONS:

1. Submit tender in a sealed envelope, indicating Quotation for “**Letter comprising of Tender for Construction of Volleyball Court in the Campus** at National Law University and Judicial Academy, Assam, at Hajo Road, Amingaon” **on or before 29-11-2018.**
2. The University will contact only bidders meeting the requirements including the rates.
3. The payment will be made after successful on-site installation of ordered items.
4. The price quoted will be applicable to the specifications mentioned in this quotation notice and total price quoted will be taken in awarding the contract.
5. Quoted rate should be inclusive of all taxes applicable at any point of time.
6. Income Tax and other statutory deductions will be made at source.
7. The bidders may, specifically mention if any higher specifications are offered.
8. The selected vendors will be required to complete the work within the time mentioned in the work order.
9. Please indicate whether you will be able to supply the item within time specified after receiving the order.
10. Please specify the minimum period for completion of the work if you are not able to complete the work within the said period. Early delivery will be a factor for consideration in deciding the successful bidder.
11. A penalty of 0.5% of the total order value will be imposed per week for late completion of work.
12. The bid should be accompanied by an earnest money deposit (EMD) of Rs. 50,000/- and to be attached in the shape of Demand Draft only drawn in favor of “ National Law University and Judicial Academy, Assam” payable at Guwahati.
13. No advance payment will be made, any offer linked with advance payment is likely to be ignored.
14. A self-declaration affidavit to be submitted that the firm had no blacklisted record for last 5 years.
15. After winning the order, if you fail to complete the work your EMD will be forfeited and you will be blacklisted from participating in any future bid/tender.
16. Only Original fabricators, dealers or their Authorized Partners of the Product can participate in the bid.

20. Submit previous work order for similar works completed successfully.
21. Submit proposed layout design in a hard/soft format for presentation during the opening of Bids.
22. Mention free maintenance and warranty period for the said job.
23. Materials **brand** with technical specification to be enclosed whenever necessary.



7. TENDER OPENING

7.1 OPENING OF TENDER:

The procedure of opening of the TENDER shall be as under:

Tenders shall be opened in the presence of designated Authority and Tenderers who wish to be present there.

7.2 CLARIFICATION OF TENDER:

7.2.1 To assist in the examination, evaluation and comparison of TENDER, NLUJAA may at its discretion ask the Tenderer for a clarification on the TENDER which is submitted by him. The request for clarification and the response shall be in writing within the specified time. No additional information or documents other than the one asked for will be accepted at this stage.

7.2.2 The University will be at liberty to involve any expert or consultant in evaluating the bid for completing the entire bid process.

8. AWARD OF CONTRACT

The Tenderer should pass in all items of "Eligibility Criteria". Eligible tenderer or tenderers quoting the lowest offer price shall be awarded the contract.

- 8.1 National Law University and Judicial Academy, Assam reserves the right of negotiation with eligible Tenderer before the finalization of the TENDER
- 8.2 National Law University and Judicial Academy, Assam reserves the right at the time of award of contract to increase or decrease the numbers of locations/quantities without any change in terms and conditions.
- 8.3 National Law University and Judicial Academy, Assam reserves the right to accept any bid and to reject any or all bids or accept any TENDER in total or in parts without assigning any reason thereof.

8.4 NOTIFICATION OF AWARD

Prior to the expiration of the period of TENDER validity, the University will inform the Tenderer by registered letter or by phone or fax or by e-mail about the selection of the bid and the award of the work.

9. PERFORMANCE SECURITY

- 9.1 Within 30 (thirty) days after the purchaser's issue of notification of award, the supplier shall furnish Performance security to the purchaser for an amount of 5% (five percent) of the contract value in form of Account Payee Demand Draft in favour of "The Registrar, National Law University & Judicial Academy, Assam", or Bank Guarantees / FDR.
- 9.2 The proceeds of the Performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete its obligations under the contract.
- 9.3 The Performance security shall be denominated in Indian Rupees.
- 9.4 The Performance security will be discharged by the purchaser and returned to the supplier on completion of the supplier's Performance under the contract.

10. INSPECTION AND TESTS

- 10.1 The purchaser or its representatives shall have the right to inspect and/or to test the goods/materials to confirm their conformity to the contract.
- 10.2 Should any inspected or tested goods/materials fail to conform to the specifications, the purchaser may reject them and the supplier shall either replace the rejected goods/materials or make all alterations necessary to meet specification requirements free of cost to the purchaser, within a period of 20 (Twenty) days of intimating such rejection.



11. EXECUTION PERIOD

The work shall be completed in all respect within 60 days from the date of award of work. In case the project cannot be completed in Scheduled time, then please mention the Minimum time required to complete the project of **Construction of Volleyball Court in the Campus at NLUJAA**. The ability to complete the work within the stipulated time will be a consideration for selecting the winning bid.


