Notice Inviting Quotation (NIQ) for Empanelment for supply of AC Vehicles

Registrar, National Law University & Judicial Academy, Assam invites sealed quotations in prescribed format from eligible bidder(s) having a fleet of 10 or more vehicles owned or leased with an experience of 2 years or above for 'Empanelment for supply of AC Vehicles' in the Office of Centre for Child Rights (CCR), National Law University & Judicial Academy, Assam, Amingaon, Hajo Road, Guwahati – 781031, as and when required.

The bidder is requested to submit sealed and signed quotation on and before 3.00 P.M. on 21.10.2017 in the Office of the 'Registrar, National Law University & Judicial Academy, Assam, Amingaon, Hajo Road, Guwahati – 781031'.

Eligibility and Terms & Condition

1. The agency/firm submitting quotation should have valid PAN Card, Trade Licence and GST Registration. Agencies/Firms are required to submit proposals in 2 covers. The fist cover shall contain PAN Card, Trade Licence, GST Registration Certificate and Annexure I. The second cover shall contain the Financial Quote/Quotation as given in Annexure II along with the list of works undertaken / supply of vehicle during the last 2(two) years. The first cover will be opened at first and agencies who have submitted PAN Card, Trade Licence and GST Registration Certificate shall be eligible for opening the second cover i.e. cover containing the Financial Quote. The order for empanelment shall be awarded to the firm submitting the Lowest financial quote (Grand Total Price). Both the covers should be enclosed in a third envelope with marked 'Quotation for Hiring of AC Vehicle- Centre for Child Rights, NLUJAA'.

- The vehicles shall be hired by CCR from the empaneled agency from time to time as per the requirements during the period of empanelment as per agreed terms and condition.
- 3. The empanelment of the Firm shall be valid upto December, 2017.
- 4. Vehicle supplied should have valid permit to ply in the jurisdiction for which it may be hired.
- 5. All vehicles provided to Centre for Child Rights should be manufactured on or after 2013.
- 6. Insurance: Comprehensive. In case of Third party insurance, all mishaps will be fully at vendor's risk.
- 7. The vehicle shall have to be supplied with experienced professional Driver who will be responsible to report for duty with the vehicle at the prefixed station within the stipulated time unless otherwise specified. The driver will have to sign Log-Book at arrival as proof of his reporting for duty.
- 8. Logbook will have to be maintained and signed by the driver and the officer using the vehicle. KM for fuel charges will be counted from pick up point.
- Supplier/owner of the vehicle shall be responsible for the all types of repair, servicing and maintenance of the vehicle.
- 10. University shall not have any liability arising out of any accident while the car is in use by the University. University shall not be liable to pay damages/consumption to the owner/Driver or any other person who may be affected by the accident.
- 11.Claim for escalation of rate due to any reason during the validity of contract period, if any, will not be entertained.
- 12. Driver with capricious, erratic, arrogant attitude or alcohol addiction should be replaced immediately; otherwise the contract will be terminated at any time.
- 13. The vehicle at times will have to undertake journey for long hours in other districts and make night halts. The driver of the car shall be prepared to halt



- with his own arrangement and cost. All the cost of the driver is to be paid by the vendors whether journey is within Guwahati or outside Guwahati.
- 14. The vehicle should be in good condition, road worthy and comfortable. If any petty repair is to be made while in tour and the officer concerned using the vehicle pays for cost of repair, the same will have to be paid by the vendor.
- 15. During the hiring period, if vehicle breaks down, the vendor should provide replacement immediately, failing which, the difference in the hire charge for another vehicle will have to be borne by the vendor.
- 16.University reserves the right to extend the validity of contract with the supplier beyond the expiry of contract period at the same terms & conditions and rate under mutual agreement by both the sides.
- 17. The rate is to be quoted both in figures and in words without any overwriting. Any correction therein must have to be attested with the signature of the owner(s)/ Quotationer(s).
- 18.No advance payment is permissible. Payment will be made once in a month or after completion of the journey. All payments are subject to deduction of all applicable Government Taxes / Duties for which a certificate of deduction in prescribed form will be issued to the vendor.
- 19.Bill/Invoice shall be raised only after the completion of the tour. University, after through scrutiny, shall release the payment, if found appropriate. In case, anything stated in the invoice found to be inappropriate, University reserves the right to rectify the same and release payment accordingly.
- 20.All disputes are subject to exclusive jurisdiction of Competent Court and Forum in Guwahati, Assam only.
- 21. Late and delayed offer will not be considered.
