1. COURSE OBJECTIVES:

The Course includes topics and sub topics of the major events of the modern

period in Indian history. It was also the period of British colonialism and

imperialism. The course intends to impart knowledge of the origins and structure

of the colonial state. It also includes topics of Indian nationalism and the national

movement that ultimately led to independence albeit with partition.

2. TEACHING METHODOLOGY:

The teaching methodology shall be participatory teaching with discussions on the

topics included. The students are informed in advance the topic for discussion and

the topic of project / assignment they have to prepare. The students prepare their

topics from the sources suggested to them. The students are also encouraged to do

independent research on their respective assignments. In the classroom every

student is required to present his/her topic and to have his/her doubt cleared

through discussion. The teacher will be helping and guiding the students in their

pursuits of learning.

3. EXPECTED OUTCOMES OF THE COURSE:

Students are expected to have acquired in-depth understanding of key historical

events in the period 1750-1950 that saw the rise of the British imperialism. They

will have gained insights into concepts of colonialism, imperialism, nationalism

and communalism that will help understand important developments in Indian

history which in turn have an important bearing on contemporary history.

4. COURSE EVALUATION METHOD

The course shall be assessed for 200 marks. The Evaluation Scheme would be as
