1. COURSE OBJECTIVES:

Companies play a significant role in a country's economy and make a special contribution to national development. The working of companies affects all facets of national life. In a mixed economy, the government's major economic policies are implemented through corporate sector. A modern company has assumed the haracter of a major socio-economic institution and public at large is vitally interested in its activities. It should function not simply as an economic machine intended to churn out profits for its shareholders, but rather as an institution which has a social responsibility to a variety of interests. This course aims to impart to the students, basic principles of corporate law, the corporate management, control, possible abuses, the remedies and government regulation of corporate business and winding up of companies. As it is impossible to cover all the components of corporate law in one semester the thrust of the course is on company law while also touching upon important regulations on capital market and foreign investment. Following are the fundamental objectives of the course;

- 1) To train students in understanding the organizational structure of companies and various forms of business.
- 2) To train students in practical application of various components of corporate law right from incorporation, corporate finance, reconstruction, management, dispute resolution to dissolution of company.

2. TEACHING METHODOLOGY

The teaching methodology for the above subject will be aim at gaining maximum theoretical as well as practical knowledge about the above subject. Different methods will be used which will help the students to be engaged in the subject apart from classroom teaching. The engagement of the students in the teaching learning process will be helpful for both the student and the teacher to carry on with the subject. It will be in the form of class room teaching and explanation of basic concepts by the teacher. It will also consists of assignment of seminar topics to the students, presentation assignment to the students, group discussions, organization of quiz etc.
