- Interested candidates may apply against the aforementioned categories through the **Online Application Form** available at <http://admissions.nluassam.ac.in/> along with **Seat Booking Fee** of **INR 50,000/-** to be paid online ( details of online payment portal will be

uploaded shortly). The payment receipt of the online transaction with **Name of Candidate** will have to be mailed to [admissions@nluassam.ac.in](mailto:admissions@nluassam.ac.in).

- The admission form link shall be available from **August 23, 2021 (12 noon) to August 25, 2021 ( 5.00pm)**
- After the receipt of applications, a Merit List (**based on CLAT, 2021 ranking**) of each Category will be published on **August 26, 2021**. Candidates who would be enlisted in the Merit List would have to deposit an amount of **Rs. 84,500/\* (for UG) and Rs. 69,750/\* (for PG)** latest by **27<sup>th</sup> August, 2021** to avail seat at NLUJA, Assam. PG candidates **who do not** opt for **Hostel & Mess Facility** of the University shall pay **Rs. 27,250/-**
- In the eventuality that NLUJAA is not able to offer seat to a candidate who has deposited the amount of Rs.50, 000 to book a seat, the full amount shall be refunded to the candidate.

- While transferring the Admission Fee, please ensure that the name of the student is mentioned in the Bank Narration for easy identification of the student on whose behalf the Fee amount has been deposited.

\*Fee for **Semester I** is being collected during admission. Fee for **Semester II** will have to be paid at the commencement of the same.
