- The Fee payable will have to be deposited in a single instalment within the prescribed date. Deposit of partial fee amount or late deposit may amount to cancellation of admission.
- It is mandatory to submit duly filled in Admission Renewal Form at the time of Fee Deposit (Annex.I). The form may be submitted to the Accounts Section at the time of DD submission.
