All the stakeholders are satisfied with the course curriculum.


Next Steps:






Does the Course Objectives and Course Learning Specific Outcome are appropriate in the light of Course Contents?




Is the Syllabus properly framed and well designed? 14 responses




Does the syllabus mitigate the needs of students in Legal Profession? 14 responses



Do you think that, the syllabus is based on recent Legal Trends? 14 responses




Do you think that, the syllabus will be useful to satisfy the needs of the Society? 14 responses




Did Teacher explained you about the course requirements for the semester? 138 responses




Are you satisfied with the course contents of your syllabus? 138 responses




Did Teachers explained you about the course learning outcome for the course? 138 responses




Instructions on curricula adopted for the course can be described as 138 responses




Development of appropriate strategies to achieve course objectives can be described as 138 responses



The choice of study materials to fulfil course objectives is 138 responses




How much of the syllabus for the course was covered in the semester? 138 responses




Teachers inform you about your expected competencies, course outcomes and programme outcomes.










1. Does the course objective and course learning specific outcome are appropriate in the light of Course Contents




2. Proper information is given about curriculum and course structure at the time of admission. ^{23 responses}




