

Dear Madam/Sir,

I have gone through the syllabi of B.A.,LL.B (Hons.) Five Year Integrated Course and found it comprehensive. Although some more concepts could have been included but looking at the course work load and the teaching hours, it appeared satisfactory. However, the following points may be considered for inclusion.

Points:

1. In the template (which will be placed at the beginning of a programme) it would be better to specify the total marks of each paper highlighting the division of the total marks e.g. total marks, internal marks, external marks etc.
2. Moreover, if possible and permitted from BCI, the code of papers may be arranged in a more systematic way considering semester, paper division: core papers, clinical papers, optional papers and specialized group and amount of credits in each paper. E.g 101-COP4 where first three/four digit indicates semester number and paper number, next three alphabets represent core papers and the last digit represents credit. This is an example from my end. There may be a better representation of the course code. Please have a discussion on it.
3. **For course 401-ECO MJ IV (Public Economics):**
 - a. In Module II: Public Revenue: Concepts of revenue receipts & non-revenue receipts, Sources: Tax & non tax revenue (Sources need to be included).
 - b. In Module III: Start with Taxation: Concepts, Cannons, types of taxation-Direct tax and Indirect tax.....
 - c. From Module II to IV, in order to familiarize students with the concepts and to give a glimpse of up to date situation in India, add one line at the end of each module: trend and dimension of the concepts/elements in Indian context.
4. **For course 402/403 ECO MN IV (I/II) [Public Finance and Indian Economic Issues]:**
 - a. In Module I: It should be Goods and Services Tax.
 - b. In Module IV: Cropping pattern may be included.
 - c. Module IV seems extensive. Looking at the maximum class hours, it is advisable to go for CONCEPT ONLY of the different subsection topics to be discussed.

In this regard, it is placed on record that the Evaluation Scheme has been proposed by the UGC in its **EVALUATION REFORMS IN HIGHER EDUCATION INSTITUTIONS** and in furtherance to the said recommended reform, the UGC conducted a workshop in Assam, where several State Universities including NLUJAA have been urged to adopt the same. Subsequently, the scheme was approved by Statutory Bodies such as the Academic Council and the Executive Council. Therefore, the matter would be referred to the General Council for their inputs on the matter.

(3) Under the proposed course evaluation method of 200 marks, the term 'External Assessment' should be replaced by the term 'End Term Assessment' or 'End Term Examination'. The recommendation will be duly incorporated.

(4) Further, certain changes were recommended in some of the syllabi placed before the Board:

(i) Prof. Manoj Kumar Sinha observed that in:

- (ii) **Investment Law-** The Board suggested the inclusion of :
 - o FDI;
 - o FDI & its impact on Human Rights;
- (iii) **Right to Information, Civil Society and Public Grievance-** In the first module, The national framework should be discussed first and international legal framework should be discussed thereafter instead of the other way around;
- (iv) The syllabus for **Basics of Industrial Design & Trade Secret Laws** should be reworked;
- (v) **International Humanitarian Law and Refugee Law-** Under Module IV, The term 'Enforcement of IHL' should be substituted with 'Courts & Tribunals'
 - o On this, Prof. Venkat Rao suggested the term '**Invocation and Application of IHL- Courts & Tribunals**'.

Further, Prof Jaswal recommended that instead of prescribing particular set of cases, Five to Ten latest case laws of the respective subject should be listed by the concerned faculty member in their syllabi (in the beginning of the session). This will enable the students to learn new cases decided by Courts and Tribunals.

Prof. Vijender Kumar suggested that- prior to course commencement, the faculty members should have the opportunity to revise their syllabi and make a presentation in front of other faculty members for requisite inputs (including interdisciplinary aspects)
