APPOINTMENT TO THE POSITION OF VICE CHANCELLOR OF THE NATIONAL LAW UNIVERSITY AND JUDICIAL ACADEMY, ASSAM (NLUJAA)

The National Law University and Judicial Academy Assam (NLUJAA), which was established under the National Law University and Judicial Academy Act 2009 (Assam Act No XXV of 2009), as amended, is an institution of excellence in Legal Education. The University is currently operating out of a temporary campus in Ulubari Guwahati, while construction work continues at its permanent site in Amingaon, across the river Brahmaputra.

A Search Committee has been constituted for the purpose of selecting a panel of names for appointment as the Vice Chancellor of the University in accordance with the provisions in the relevant statutes.

The Vice Chancellor, being the academic as well as administrative head, is expected to be:

- A senior legal academic of high repute having outstanding academic record throughout, with experience of 10 years as a Professor of Law in a University system or in an equivalent position in a reputed research and / or academic / administrative organization.
- A visionary with proven leadership qualities, administrative capabilities and excellent teaching and research credentials.
- A person who has made a significant contribution to knowledge.
- A person who shall be committed to the growth of this new Institution.
- **Not more than 65 years of age** as on the closing date of receipt of Expressions of Interest / Nominations

Salary & Service Conditions

- The post carries a pay of Rs. 75,000/- (Fixed) per month with Special Allowance of Rs. 5,000/- and other usual allowances.
- The Vice Chancellor will be entitled to other benefits including housing and conveyance as per Rules on appointment.
- The term of the Vice Chancellor shall be three years.

Procedure of appointment

- Appointment shall be made from a panel of names recommended by the Search Committee and with the approval of all statutory authorities.
- Expressions of Interest / Nominations that are received from eligible Individuals / Nominators latest **by 04.08.2014 (Monday)** shall be considered by the Committee.
- The Search Committee shall, however, reserve the right to consider any other eligible person (s) or to invite other names it considers appropriate from higher educational institutions of repute and not limit itself to the names collated from the Expressions of Interest / Nominations received in response to this public notification/ advertisement.
- The Search Committee solicits submission of **up-to-date CVs** (including email addresses) and a **statement on the Vision** that the Expresser of Interest / Nominee has for the University and desires that these be sent by email to registrar@nluassam.ac.in with a copy to arps5600@gmail.com within the stipulated timeline.
- **Academics who had submitted Expressions of Interest in response to the earlier public notice issued in April 2014 need not apply again as their candidatures will be automatically considered.**
- **No Nominations are required to be made in respect of those academics whose Nominations were received against the earlier public notice issued in April 2014 as their candidatures will also be automatically considered.**
