- 2. The envelope should be **super-scribed** as "Application for the post of <--name of the post -->".
- 3. E-mail addresses of the candidates (if any) must be mentioned in the proper place of the Application Form
- 4. **Only shortlisted candidates will be called for interview**. The University reserves it's right to place reasonable limit on the total number of candidates to be called for interview. Fulfillment of essential qualifications per se does not entitle a candidate to be called for interview.
- 5. Stringent criteria may be applied for short-listing the candidates to be called for interview.
- 6. The University reserves the right to relax any requirements of experience and age for exceptional candidates, especially for those from reputed educational/research Institution and having a good track record;
- 7. The University reserves the right to withdraw any advertised post at any time without assigning any reason. The right is also reserved with the university either to fill or not to fill the post and its decision in this regard shall be final.

- 8. The University reserves the right to modify/cancel/withdraw any communication made to the candidates(s), even after appointment, if this has been the result of some inadvertent mistake either in the advertisement or the recruitment process which may have been detected at a different stage;
- The University reserves the right to disqualify any candidate who may have been shortlisted based on wrong information provided by the candidate. Persons who may be selected/ appointed based on wrong information supplied by the candidate may be terminated at any stage;
- 10. The application form duly filled in the prescribed form must reach the office of the Deputy Registrar on or before the **last date** at the under-mentioned address. Applications received after this date shall not be included in the selection process. **Applications received through emails will not be considered.**
- 11. Applicants serving in Government/Semi-Government organizations/Public Sector Undertakings/Autonomous Bodies must send their applications **Through Proper Channel**. The applications received without the recommendations of the employers will not be considered. However, an advance copy of application may be sent followed by the original application through proper channel.
- 12. Candidates shall have to produce original documents at the time of appearing in Interview.
- 13. Canvassing in any form may lead to cancellation of candidature.
- 14. **Incomplete applications** or without relevant supporting enclosures (self-attested copies of degree/certificates/marks sheets/experience certificate, etc.) will be **rejected at the threshold.**
- 15. Two copies of photographs and a Demand Draft of Rs. 500/- (Five Hundred) for General candidates and Rs. 250/-(Two Hundred Fifty) for SC/ST/PWD candidates for the posts of Assistant Engineer and Lady Warden-cum-Matron.
