IN THE CLASSROOM THE STUDENTS ARE REQUIRED TO PRESENT THEIR TOPICS AND TO ACTIVELY PARTICIPATE IN GROUP DISCUSSIONS.

THE TEACHER SHALL HELP AND GUIDE THE STUDENTS IN THEIR PURSUIT OF LEGAL LEARNING.

THE TEACHER SHALL RECAPITULATE AFTER THE STUDENTS HAVE COMPLETED THEIR DISCUSSION, AND DOUBTS, IF ANY, ARE CLARIFIED.

3. LEARNING OUTCOME OF THE COURSE

THE ISSUES WHICH SHALL BE DISCUSSED IN THESE READINGS ARE EXPECTED TO FACILITATE STUDENTS TO DEVELOP A HEIGHTENED ECOLOGICAL CONSCIOUSNESS.
