## **1. COURSE OBJECTIVES**

When it comes to understanding the laws relating to children, the focus is largely on municipal legalisations but the truth remains that there is an entire gamut of international legal regime that acts as the precursor or light bearer to most of these municipal legal regimes. The objective of this course is to enhance the understanding of the students on various international instruments and mechanisms pertaining to child rights to build a better understanding on the child rights scenario, nationally as well as globally.

The objectives of the course, in particular, are as follows:

- To familiarize students with the conceptual framework of child rights as human rights;
- To provide them with an understanding of child rights vis-à-vis international labour law, criminal law, humanitarian law and human rights law;
- To understand the UNCRC in detail;
- To analyse child law from a gender perspective;
- To enhance capacity of students to form their own opinions on vital child law issues.

## **2. TEACHING METHODOLOGY**

The teaching methodology shall aim at the generation of critical thinking among the students. The topic for a particular class shall be informed to the students beforehand and readings shall be assigned to them for the said topic. They are expected to have a basic idea about the topic prior to the class. Subsequent to a brief lecture on the topic, there shall be class discussion on the same as well as on the readings assigned. Pursuant to the class discussion, the teacher shall substantiate the issues raised and answer any questions posed or left unanswered. Case study method shall be also adopted for relevant topics.

## **3. EXPECTED OUTCOMES OF THE COURSE**

At the completion of the course, it is humbly expected that the students shall:

- Comprehend the subject matter of the course
- Be able to analyze contemporary child rights law problems in the light of the concepts learnt
- Be able to articulate their ideas on the subject matter of the course
- Produce at least one research paper of publishable quality
- Desire to take up child rights law for further studies
