1. COURSE OBJECTIVES

THIS COURSE OBJECTIVE IS TO INFORM STUDENTS ABOUT FEMINIST JURISPRUDENCE. THE STUDENTS SHALL ALSO DEVELOP AN UNDERSTANDING ABOUT THE STATUS OF WOMEN THROUGHOUT HISTORY, BEGINNING WITH THE VEDIC PERIOD AND CONCLUDING IN THE POST-INDEPENDENCE ERA.

THE STUDENTS SHALL TRY TO COMPREHEND FEMINIST LEGAL THEORY WHICH ENGAGES WITH CHANGING WOMEN'S STATUS THROUGH A REWORKING OF THE LAW AND ITS APPROACH TO GENDER.

2. TEACHING METHODOLOGY

THE TEACHING METHODOLOGY SHALL BE LEARNER- CENTRIC IN NATURE WHICH WILL GIVE AMPLE SCOPE TO THE STUDENTS TO ACTIVELY PARTICIPATE IN THE LEARNING PROCESS.

THE STUDENTS ARE ENCOURAGED TO DO INDEPENDENT RESEARCH ON TOPICS OF THEIR CHOICE WITH GUIDANCE FROM THE TEACHER. THE STUDENTS PREPARE THEIR TOPICS FROM THE SOURCES SUGGESTED TO THEM.

2. LEARNING OUTCOME OF THE COURSE

AFTER COMPLETING THE COURSE, THE STUDENTS WILL HAVE A FOUNDATIONAL IDEA OF FEMINIST LEGAL THEORY AND FEMINIST JURISPRUDENCE. THE STUDENTS SHOULD BE ABLE TO EVALUATE THE KEY CONCERNS OF WOMEN AND LAW THROUGH A READING OF THE TEXTS PRESCRIBED IN THE COURSE.
