## 1. COURSE OBJECTIVES

THIS COURSE AIMS TO EXPLORE THE INTERSECTION OF LAW AND LITERATURE BY READING LITERARY TEXTS AS LEGAL TEXTS AND LEGAL TEXTS AS LITERARY TEXTS. THIS SHALL INCLUDE A READING OF NARRATIVES FROM ANCIENT TIMES TO THE CONTEMPORARY TIMES.

THIS COURSE SHALL ALSO HIGHLIGHT THE PIVOTAL ISSUES AND CONCERNS OF THE AUTHORS.

THE OBJECTIVE SHALL BE TO ACCLIMATIZE THE LAW STUDENTS WITH LITERATURE WHICH WILL HELP THE STUDENTS TO BE COHERENT AS INDIVIDUALS, READERS AND CRITICS, AND DEVELOP READING POSITIONS THAT WILL FACILITATE THEIR ENGAGEMENT WITH ALL THE LITERATURE THEY WILL STUDY IN THE MAJOR COURSE.

#### 2. TEACHING METHODOLOGY

THE TEACHING METHODOLOGY SHALL BE LEARNER- CENTRIC IN NATURE WHICH WILL GIVE AMPLE SCOPE TO THE STUDENTS TO ACTIVELY PARTICIPATE IN THE LEARNING PROCESS.

THE STUDENTS ARE ENCOURAGED TO DO INDEPENDENT RESEARCH ON TOPICS OF THEIR CHOICE WITH GUIDANCE FROM THE TEACHER. THE STUDENTS PREPARE THEIR TOPICS FROM THE SOURCES SUGGESTED TO THEM.

IN THE CLASSROOM THE STUDENTS ARE REQUIRED TO PRESENT THEIR TOPICS AND TO ACTIVELY PARTICIPATE IN GROUP DISCUSSIONS.

THE TEACHER SHALL HELP AND GUIDE THE STUDENTS IN THEIR PURSUIT OF LEGAL LEARNING.

THE TEACHER SHALL RECAPITULATE AFTER THE STUDENTS HAVE COMPLETED THEIR DISCUSSION, AND DOUBTS, IF ANY, ARE CLARIFIED.

## 3. EXPECTED OUTCOMES OF THE COURSE

THE FIRST PAPER IN THIS ENGLISH MAJOR COURSE OFFERS BASIC READINGS THAT ADDRESS SOME OF THE QUESTIONS RELEVANT TO THE AREA OF LITERATURE AND THE LAW.

THE ISSUES WHICH SHALL BE DISCUSSED IN THESE READINGS ARE EXPECTED TO GIVE STUDENTS A FOUNDATION IN IDEAS THAT WILL HELP IN THE READINGS OF LITERARY TEXTS IN THESE PAPERS.

STUDENTS WILL SUMMARIZE AND CLASSIFY DEFINITIONS OF LITERARY AND LEGAL TERMS.

STUDENTS WILL COMPARE THE NARRATIVES OF LAW AND THE NARRATIVES OF LITERATURE BY READING THE GIVEN TEXTS AS LEGAL TEXTS.

STUDENTS WILL EVALUATE THE CONTRIBUTION OF THE FIELD OF LAW AND LITERATURE TO THE INTERSECTION OF HUMANITIES AND SOCIAL SCIENCES.
