# About The LL.M Programme

The LL.M. programme offered by the National Law University and Judicial Academy, Assam (NLUJAA), in collaboration with the Indian Institute of Corporate Affairs (IICA), is a distinctive postgraduate degree in Corporate Law and Management. The programme has been conceptualised in response to India's growing demand for highly skilled corporate law professionals, particularly those equipped with practical expertise in representing clients before specialised adjudicatory and regulatory forums. These include the National Company Law Tribunal (NCLT), National Company Law Appellate Tribunal (NCLAT), Debt Recovery Tribunal (DRT), Debt Recovery Appellate Tribunal (DRAT), Securities and Exchange Board of India (SEBI), Securities Appellate Tribunal (SAT), Competition Commission of India (CCI), Investor Education and Protection Fund Authority (IEPFA), Insolvency and Bankruptcy Board of India (IBBI), National Financial Reporting Authority (NFRA) as well as the High Courts, the Supreme Court of India, and other regulatory bodies.

India currently faces a significant shortage of corporate lawyers equipped with advanced training and hands-on exposure to complex corporate, commercial, and regulatory matters. In this context, there is an urgent need to cultivate a robust ecosystem of professionally skilled legal experts capable of effectively supporting law firms, consultancies, regulatory authorities, corporate entities, and academia. This LL.M. programme is designed to bridge this critical gap by integrating rigorous legal education with managerial insights, policy-oriented analysis, and strong practical orientation. Designed as a specialised and future-oriented programme, the LL.M. in Corporate Law and Management equips students with advanced knowledge, professional competence, and analytical skills required to navigate the dynamic and evolving landscape of corporate regulation in India. Through a carefully structured curriculum, students engage with core theoretical foundations, practical applications, and in-depth case studies in areas such as corporate governance, regulatory compliance, corporate restructuring, and evolving regulatory frameworks.

The programme follows a dual-campus model, enabling students to benefit from the academic strengths of two premier national institutions. The first year of the programme is conducted at the NLUJAA campus in Guwahati, where students focus on mandatory courses such as Research Methodology, Law and Justice in a Globalized World, and Fundamentals of Corporate Law, alongside specialised subjects including Finance, Corporate Governance, Corporate Restructuring, Insolvency, and Valuation. Collectively, these courses are designed to build a strong academic, analytical, and professional foundation for advanced study and practice in corporate law. The curriculum emphasizes experiential learning through project work, presentations, and intensive classroom interactions, including specialised research-based projects. Students will be mentored by dedicated experts who will provide continuous guidance on emerging regulatory developments in Corporate and allied laws, ensuring that students remain updated with the latest legal and policy frameworks.

The second year of the programme is conducted at the Indian Institute of Corporate Affairs (IICA), Manesar, an autonomous institution under the Ministry of Corporate Affairs, Government of India. This phase of the programme places strong emphasis on advanced and specialised courses, including Commercial Mediation, Trade and Investment Laws, Intellectual Property Rights and Competition Law, Environmental, Social and Governance (ESG), Securities Market Regulation, Corporate Taxation, and Banking Laws.

The Programme fosters a holistic learning journey that equips students for successful careers in Corporate Law and Management, while simultaneously immersing them in the rich cultural diversity and dynamic professional landscape of India's Northeastern region.

## About NLUJA, Assam

---

National Law University and Judicial Academy, Assam was established by the National Law University and Judicial Academy, Assam Act, 2009 (Act No. XXV of 2009) as the fourteenth National Law University of the country in Guwahati, the capital city of Assam.

With the hallowed objective to impart comprehensive legal education and promote legal research, NLUJA, Assam embarked on a scintillating voyage in the year 2011. The University has had a head start, with luminaire like Hon'ble Mr. Justice Madan Lokur laying a firm foundation for its journey unto academic excellence. In the initial days, NLUJA, Assam operated out of the premises of North Eastern Judicial Officer Training Institute, Guwahati.

# Campus Infrastructure

The University is built on a sprawling 50 acres of beautiful landscape at Amingaon, Guwahati, which is situated on the North bank of the River Brahmaputra with an imposing hill on the other side. The campus, at present, houses the Administrative Block, Academic Block, Boys' Hostel, Girls' Hostel, Library, Stadium, Cafeteria, Power House, Security Barrack, Guest House and Staff Quarters where all modern amenities are available. Construction of Auditorium, Quarters for teaching staff, and Vice-Chancellor's Bungalow are underway. Judicial Academy, Assam is located in the University campus, a unique experiment in legal education in which Judicial Academy and the University co-exist in the same precinct. National Law University and Judicial Academy, Assam campus has state-of-the-art infrastructure. The air conditioned Academic Block is equipped with sophisticated facilities such as customised class rooms with smart board, LCD screen, projector, spacious seating arrangements, etc. Located in the Administrative Block is the Moot Court Hall furnished with all the requirements of a regular bench of a High Court and a spacious seating arrangement for 150 students. Further, the Conference Hall situated in the Administrative Block is accoutered with world-class facilities to conduct national and international conferences, seminars and workshops. In addition, there are a number of meeting rooms, discussion lounges, faculty rooms, various Academic Centres facilitated with all modern amenities in the Academic Block.



# Campus Infrastructure

Adjacent to the Academic Block is the Administrative Block with modern facilities housing the VC's Office, Offices of the Registrar, the Finance Officer, the Deputy Registrar and Assistant Registrars. The Academic, Administrative, Finance and Engineering Sections are also located herein. Well facilitated Meeting Hall and Conference Hall are located in the Administrative Block where meetings of Statutory Bodies and other academic and administrative functions are organized. National Law University and Judicial Academy, Assam has a well-equipped Health Centre to provide first-aid and basic medical facilities. To respond to any kind of medical emergency the University provides 24x7 ambulance service. The University also provides an air-conditioned bus for transportation of students for their academic visits to Courts, Legal Aid Camps and for other co-curricular activities. Two hostels, one for boys and the other for girls, with single and double occupancy rooms, smokeless kitchen, spacious dining area, reading hall, gymnasium, yoga facility, prayer hall and library room, etc. are located in the campus. A Counselling Centre has been established and an experienced counsellor has been appointed by the University to address issues relating to academic and non-academic stress, and to foster positive behaviour and personality development among students. The University provides barrier free infrastructural facilities in all its buildings for Persons with Disability (PwD).





## University Library

National Law University and Judicial Academy, Assam Library has a collection of more than twelve thousand titles in the field of Law, Social Sciences and Humanities. Over the years, the library has procured various Law Journals, both print and electronic. Online databases such as LexisNexis, Manupatra, JSTOR, Westlaw India, SCC Online, HEIN Online, DELNET, Cambridge Book Online, and ELGAR have also been made available to facilitate access to quality material by students, research scholars, faculty members and visiting scholars. The University provides Remote Access Facility to the students and faculty members while they are away from campus. With the use of VPN connectivity, the e-resources and databases can be browsed via internet irrespective of the physical location of the user.

# Eligibility and Selection Criteria

## PROGRAMME

### 2-YEAR LL.M IN CORPORATE LAW & MANAGEMENT

## ELIGIBILITY

- a) LL.B. Degree or any other Bachelor Degree in Law with a minimum of fifty percent (50%) marks or its equivalent grade (forty five percent (45%) marks or its equivalent grade in case of candidates belonging to SC/ST categories).
- b) Candidates appearing for their final year examination of the qualifying are also eligible to apply.
- c) There is no upper age limit for appearing for the Course. In addition to complying with the eligibility as mentioned above, selection will be based on the merit in the entrance examination coupled with personal interview conducted by the University.

## TEACHING PEDAGOGY

The pedagogy of the LL.M. Programme in Corporate Laws and Management is designed to ensure a rigorous, immersive, and practice-oriented learning experience. The programme adopts an integrated teaching model that brings together experienced academicians, senior practitioners, policy experts, and industry professionals, thereby bridging the gap between doctrinal legal knowledge and real-world corporate and

A diverse range of teaching and learning methods will be employed, including interactive lectures, case study analysis, problem-based learning, simulations, drafting exercises, regulatory compliance workshops, group discussions, seminars, and practitioner-led sessions. Emphasis will be placed on developing analytical skills, strategic thinking, and practical competencies essential for contemporary corporate legal practice.

In addition, specialised and customised training modules will be conducted by the Indian Institute of Corporate Affairs (IICA), in collaboration with NLUJA, Assam, focusing on emerging areas of corporate governance, regulatory compliance, sustainability, ESG frameworks, and policy implementation. These modules will provide participants with direct exposure to institutional practices, regulatory perspectives, and industry expectations.

The pedagogy is thus structured to equip students with a nuanced understanding of corporate laws and management, while fostering professional competence, ethical responsibility, and leadership readiness in an increasingly complex corporate and governance environment.

The medium of instruction of this course will be English.

# Application Process

**How to apply :** The Online portal for submitting the application form for admission shall be open on the website of NLUJA, Assam and all the candidates should apply online.

**STEP 1:** The candidate should register by providing the email id, Mobile number and other details on the registration page. After completion of the registration, the login details will be sent to the registered email id (please check spam mails as well).

**STEP 2:** The candidate should login using the login id and password.

**STEP 3:** For complete details, kindly go through the Admission Notification and Admission Brochure, which is available on the Registration Page of NLUJA, Assam and IICA websites and proceed for filling the application form.

**STEP 4:** Fill all the details in the application form. All mandatory fields (with\*) should be filled compulsorily. Upload all the documents, photograph and specimen signature as listed in the application form.

**STEP 5:** After filling all the details PRESS 'SAVE' to save the data entered by you. Candidates can login and keep entering/ modifying the data till payment is done.

**STEP 6:** After filling all the details, the next step is to make the Payment. Make the payment choosing the relevent category of application fees.

**STEP 7:** If your payment transaction is successful, the fee receipt will be generated and the same along with the filled in application form will be available on the DASHBOARD. If the payment transaction failes, then you need to do the payment process again till your transaction is successful.


## Award of Degree, Batch Size, Seat Conversion Rule, Credit System

# Examination Process

---

Students must log in to the Online MCQ Examination portal by entering their user name and password, entering the captcha displayed on the screen, and selecting the checkbox to accept the Terms of Use and Privacy Policy before clicking on the Login button. Upon successful login, the student's image will be captured for verification, during which the student must hold a valid ID card clearly visible.

After logging in, students will be able to view examination details such as the examination start and end date, time zone, number of questions, and remaining time. Students must then click on the Proceed button, after which a pop-up window displaying the candidate details will appear. The details must be carefully cross-checked, followed by clicking on "I Agree" and the Confirm button to continue.

Subsequently, the system will request permission to access the web camera. Once permission is granted, examination instructions will be displayed on the screen. After reading and understanding the instructions, students must click on "I've read and understood the instructions" and then on "I am ready to begin" to start the examination.

The online examination window will display the examination timer in the top right-hand corner and the question along with the multiple-choice options in the main window. Students must select the appropriate option and click on "Save and Next" to record their response, while the system automatically saves all answers. Students may navigate through the examination using the Previous, Save and Next buttons, and the question grid provided on the right side of the screen. Questions may be marked for review and revisited later, and all questions marked for review will be considered as attempted final answers at the time of submission. The question grid will indicate the status of questions using different colors, namely green for attempted questions, grey for unattempted questions, blue for attempted questions marked for review, and purple for unattempted questions marked for review.

Throughout the examination, students will be monitored through remote proctoring and will be under continuous supervision. Students are strictly prohibited from talking to anyone, referring to books or study materials, or opening any external tabs during the examination, and any such act will be treated as examination malpractice.

After completing the examination and reaching the last question, the Submit Test option will become visible. Upon clicking this option, a test summary window will be displayed showing the number of attempted, unattempted, and marked-for-review questions. Students must confirm their submission by clicking Yes to submit the test or No to return to the examination. Once the test is submitted, the examination will be marked as complete.
