 - viii. PwD / SAP Certificate, if applied and allotted under the PwD category
 - ix. Domicile/Residence Certificate, if applied and allotted under the domicile / resident category seat ix. Identity proof.
 - x. Affidavits I-VIII whichever is applicable.
