- b. CLAT 2025 score card
- c. Grade 12 statement of marks
- d. LL.B./B.L./Equivalent Degree Statement of Marks.
- e. Character Certificate/Conduct Certificate from the Educational Institute last attended.

- f. Transfer/Migration Certificate from the Educational Institute last attended.
- g. Cast Certificate (SC, ST, OBC NCL etc.) if applied under the Reserved category of seat.
- h. PwD/ SAP Certificate, if applied under PwD Category
- i. Permanent Residence Certificate, if applied under the domicile /resident category seat.
- j. Documents to claim seat for Ward of Defence Personnel and EWS categories.

The admission form link shall be available from July 11, 2025 to July 16, 2025 (12 Noon)

- After the receipt of applications, a Merit List (based on CLAT, 2025 ranking) of each Category will be published on **July 16**, **2025**. Candidates who would be enlisted in the Merit List would have to deposit an amount of **Rs. 2,11,500**/- (for PG candidates who opt for Hostel and Mess Facility of the University) and **Rs. 1,19,500**/- (for PG candidates who do not opt for Hostel and Mess Facility of the University) latest by **July 20, 2025 (5 P.M.)** to avail seat at NLUJA, Assam.
