INVITING ONLINE APPLICATIONS FOR ADMISSION TO U.G. AND P.G. PROGRAMMES UNDER VACANT SEATS (ACADEMIC SESSION 2026-2027)

All interested and eligible candidates are hereby informed that online applications are invited for admission to the **B.A.,LL.B.(Hons.) Five Year Integrated Programme** and **One Year LL.M. Degree Programme** at National Law University and Judicial Academy, Assam for the Academic Session 2026-2027. Admissions shall be made on the basis of the valid score of the Common Law Admission Test (CLAT-2026) conducted by the Consortium of National Law Universities.

ELIGIBILITY CRITERIA:

Admission to the B.A.,LL.B.(Hons.) F.Y.I.C Programme and One Year LL.M. Degree Programme shall be made strictly on the basis of the valid CLAT-2026 score. Candidates must have a valid CLAT-2026 score and will be admitted in accordance with the seat matrix and reservation policy of the University.

GUIDELINES/INSTRUCTIONS FOR ADMISSION:

1. Admission of any candidate is liable to be cancelled without further notice at any time during the programme, if it is found that the candidate has produced fake/forged certificates or documents, or has indulged in any act of misconduct/indiscipline/moral turpitude, or has concealed any relevant information at the time of seeking provisional admission. Such candidates shall also be liable to be prosecuted under the Law.
2. Any attempt by the candidate or anyone else on his/her behalf to influence or pressurize any Authorities/Admission Committee of the University, directly or indirectly, for out-of-rules admission, shall disqualify the candidate from admission. Such candidates shall also be liable to be prosecuted as per the provisions of Law.
3. Candidates applying under reserved categories shall have to produce valid certificates in support of their claim. For OBC (NCL)/EWS categories, certificates need to be produced for the current year.
4. **Vacant seats are subject to change based on admission/withdrawal of admission from any specific category seats.**

The admission form link shall be available till **June 15, 2026 (Midnight)**. With reference to the notification for admission against vacant seats published on **04.06.2026**, the last date for submitting the online application form has been extended until **June 15, 2026 (Midnight)**.

After the receipt of applications, a Merit List (based on CLAT, 2026 ranking) of each Category will be published on **June 17, 2026**.

U.G. Candidates who would be enlisted in the Merit List would have to deposit an amount of **Rs. 2,53,600/- (Two Lakh Fifty-Three Thousand Six Hundred Only)** latest by **June 22, 2026 (5 P.M.)** to avail seat at NLUJA, Assam.

P.G. Candidates who would be enlisted in the Merit List would have to deposit an amount of **Rs. 2,18,600/-** (for PG candidates who opt for Hostel and Mess Facility of the University) and **Rs. 1,25,000/-** (for PG candidates who do not opt for Hostel and Mess Facility of the University) latest by **June 22, 2026 (5 P.M.)** to avail seat at NLUJA, Assam.

Note:

1. Candidates claiming seats in the reserved category are to submit Caste Certificates/Permanent Resident of Assam Certificate (PRC)/PWD Certificate/ OBC(NCL)/MOBC (NCL) Certificate whatever applicable.
2. Candidates claiming seats under the domicile/resident category seat are to submit Permanent Residence Certificate (PRC) at the time of verification of original documents.
