The 4<sup>th</sup> Gurjeet Singh Memorial National Moot Court Competition was conducted on 26<sup>th</sup>-28<sup>th</sup> May 2023. The moot proposition was drafted on Constitutional law and its allied aspects keeping the Cable TV Network (Regulation) Act, of 1995 as the parent statute. This edition was remarkable in its own unique way as it saw the participation of 40 teams across the nation. This put a huge burden on the part of the organizing committee which had to pull off the event smoothly. With the efforts of the student fraternity, not to mention the constant aid and guidance of our esteemed faculty members, the blueprint of the edition finally manifested.
