Report: 5th Gurjeet Singh Memorial National Moot Court Competition 2024

Introduction

The 5th Gurjeet Singh Memorial National Moot Court Competition 2024, organized in collaboration with the National Human Rights Commission (NHRC), was held from 24th to 26th May 2024 at the National Law University and Judicial Academy, Assam. With a compelling theme, "Ensuring Human Rights by Combating Gender Discrimination and Promoting Equal Opportunities," this year's moot court competition attracted 20 teams from across the country. The event provided a platform for participants to showcase their legal research, advocacy skills, and their ability to tackle pressing human rights issues.

Day 1: 24th May 2024

The inaugural day of the competition set a professional and enthusiastic tone for the event.

Inaugural Ceremony:

- Chief Guest Address: The ceremony commenced with the address by Chief Guest Shri Arup Kumar Goswami, Chairperson of the Assam Human Rights Commission. - **Researcher Test:** The researcher test was conducted to evaluate the participants' proficiency in legal research. This test was designed to assess their understanding of the competition's theme and their ability to perform detailed legal analysis.
- **Draw of Lots and Memorial Exchange:** The draw of lots determined the preliminary round matchups, while the memorial exchange allowed teams to swap their written submissions, setting the stage for oral arguments. This activity was crucial for ensuring that each team had an equal opportunity to present their case.

The first day concluded successfully with all initial activities completed as planned, setting a promising tone for the upcoming rounds.

Day 2: 25th May 2024

The second day was dedicated to the preliminary and quarter-final rounds, which were characterized by high levels of engagement and competitive spirit.

Preliminary Rounds:

- **Conduct of Rounds:** Two preliminary rounds were held, where each team presented its case arguments based on the competition's theme. The arguments were assessed for their legal reasoning, presentation skills, and adherence to the theme.
- **Evaluation and Feedback:** Teams received feedback from judges, which was instrumental in preparing for the subsequent rounds. The judges provided insights on the strengths and areas for improvement in the participants' arguments and presentation styles.

Quarter-Final Round:

- **Selection of Semi-Finalists:** The quarter-final results determined the four teams that advanced to the semi-final round. The selection process was rigorous, reflecting the high standards of the competition.

The day concluded with the announcement of the semi-finalists, creating anticipation for the final stages of the competition.

Day 3: 26th May 2024

The final day of the competition was marked by the semi-final and final rounds, showcasing the best performances of the tournament.

Semi-Final Round:

- **Adjudication by Senior Advocates:** The semi-final round was adjudicated by esteemed senior advocates from the Gauhati High Court. Their extensive experience provided a critical evaluation of the teams' performances, focusing on the quality of arguments and legal reasoning.
- **Progression to Finals:** Based on the semi-final performances, the top two teams were selected to compete in the final round. The semi-finals highlighted the exceptional skill levels of the competing teams.

Final Round:

- **Judging Panel:** The final round was presided over by three distinguished judges from the Gauhati High Court: HMJ Kaylan Rai Surana, HMJ Manish Choudhury, and HMJ Mridul Kumar Kalita. Their expertise ensured a thorough and fair evaluation of the final arguments presented by the top teams.
- **Outcome:** After a compelling final round, Campus Law Center, Delhi emerged as the winner of the competition. The team demonstrated outstanding legal skills and a deep understanding of the competition's theme. Tamil Nadu

- **Best Memorial Respondents:** NUSRL, Ranchi Recognized for the best written submissions representing the respondents' side.

- **Prize Distribution:** The ceremony featured the distribution of trophies and certificates to the winners, runners-up, and recipients of individual awards. Each award was presented with a brief overview of the recipient's performance and contributions.

The National Law University and Judicial Academy Assam recently played host to an impactful intra-college event—the 6th Capacity Building Moot Court Competition. Aimed at providing a platform for first-year law students to refine their advocacy skills, the event was designed to foster legal acumen and familiarize participants with practical aspects of courtroom proceedings.

Judicial Expertise Elevates the Competition:

Distinguished advocates from the Guwahati High Court lent their expertise as judges, adding a layer of professionalism to the competition. This not only elevated the significance of the Capacity Building Moot but also provided students with a unique opportunity to engage with experienced professionals in the field. A total of 20 judges were invited for the Preliminary Rounds of the CBM.

Enthusiastic Participation:

The Capacity Building Moot witnessed enthusiastic participation from twenty teams, each comprising first-year law students. The teams showcased their research, analytical, and argumentative abilities while addressing legal issues related to the Constitution. The moot problem challenged participants to apply theoretical knowledge to real-world scenarios, encouraging a comprehensive understanding of the subject matter. The Moot Problem was authored by Mr. Tathagat Sharma (Advocate, Supreme Court of India), assisted by Mr. Rajat Kumar Garg.

Structured Competition Unfolds:

The event unfolded in several stages, with participants forming teams within their peer groups and selecting mentors from senior batches, facilitated by the Moot Court Committee. Submissions of memorials (written submission) took place by November 22, with a researcher's test conducted on November 25, emphasizing the importance of research in

advocacy. The test was followed by a draw of lots and an exchange of memorials. The method of draw of lots was used to form the fixtures of the oral rounds. The Oral Rounds of the competition took place on 26th November (both the Preliminary rounds were conducted that day) and finally on 29th November, the Valedictory Ceremony of the event took place.

Oral Rounds and Judicial Feedback:

The culmination of the event occurred on November 26 with the oral rounds, where esteemed advocates from the Guwahati High Court served as judges. Their involvement added authenticity to the competition, giving students insight into the expectations and standards of the legal profession. Judges provided constructive feedback, contributing to the overall learning experience. Preliminary rounds involved rigorous scrutiny of legal arguments, research depth, and presentation skills, with participants engaging in spirited debates to demonstrate their grasp of legal principles.
