LEGAL AWARENESS AND LEGAL AID PROGRAMME Date: 16th November, 2023

On November 16, 2023, the National Law University and Judicial Academy, Assam, in collaboration with its Pro Bono Club under the auspices of the Department of Justice, Ministry of Law & Justice, Government of India, organized a Legal Awareness and Legal Aid Programme. The event, conducted by a team of *Nyaya Bandhus* (Pro Bono volunteers) under the abled guidance of Prof. Dr. Diptimoni Boruah, aimed to foster legal awareness and provide insights into the legal aid avenues available to the community.

The *Nyaya Bandhu* team, comprising seventeen students from the Ist to the IVth year, commenced the programme at Bamon Sualkuchi, Hajo, Kamrup, reaching the venue promptly at 11:00 a.m. The event officially commenced at 12 noon with an introductory

speech by Prof. Dr. Boruah, offering insightful overview of the Indian Legal system. Her address covered crucial topics such as *nyayayik vyavastha* (judicial system), the Constitution, and Article 39A, emphasizing the importance of free legal aid.

Dr. Boruah also shed light on the advocate's role and detailed aspects of the Victim Compensation Act, 2012, with specific focus on cases involving

accident claims, mob lynching, dowry death, acid attacks, and more.

The attendees, which mostly consisted of the local people inhabiting the area included housewives and elderly men of the community and they were provided with detailed information on the application process for availing free legal aid through the District Legal Service Authority (DLSA) or the *zila pradhikaran* (local authorities).

Additionally, an emphasis was placed on resolving business-related matters through alternate dispute resolution mechanisms such as arbitration and mediation. The Pro Bono Club to provide comprehensive legal assistance and connect individuals who are in need with lawyers who provide free legal aid.

Then onwards, a brief singing performed by some of volunteers in the session in order to add an entertaining interlude, and thus, creating a balanced and engaging atmosphere.

Next a speech was delivered by *Nyaya Bandhu* Mr. Vishwajeet Kumar, a IVth year student at NLUJA, Assam on "*Apradhik Nyaya Pranali*" or the Criminal Justice System, in which he provided clarity to the attendees on cognizable and non- cognizable offenses, F.I.R, bailable & non- bailable offenses among other things. The topic of child marriage was taken up by *Nyaya Bandhu* Ms. Munmun Buragohain who is also a IVth student at the university with Dr. Boruah providing insights on domestic violence and related offences against women.
