Subject: Report on Mentor- Mentee Programme

Respected Madam,

I would kindly like to inform you that I have organised a meeting with the students of the 1<sup>st</sup> year (1<sup>st</sup> semester), odd semester allotted to me for mentorship on 21st November 2022 for the academic year 2022-23. A total of 11 students were present out of sixteen students. They conveyed some common academic and other grievances which they have been facing and are stated as under:

- a. To extend the timing of library during weekdays so that they could devote more time in library study and that the library should remain open during weekends (only the ground floor/reading section) remains open on weekend.
- b. Lack of updated editions of books on laws and social sciences in the library. Also the syllabus oriented books on laws are lacking. For the subject Political science, the books are mostly on Indian Politics and for History and Economics limited books are there in the library. Additionally, the updated versions of journals are also lacking.
- c. Shortage of study tables in the hostel room and also some of the tables are broken.
- d. No proper cleaning of the hostel rooms is done.
- e. Requirement of a clean and hygienic canteen with good ambience where the get quality food at a subsidised rate. The current existing canteen food is a bit expensive and also less hygienic.

In furtherance of the above cited problems, I have intimated the respected departments about the same and requested them to take appropriate action.

## "Learn to Teach" Policy for LLM Students

With a view to inculcate teaching skills in the LLM students, the Post Graduate Centre for Legal Studies, National Law University Assam introduces "Learn to Teach" policy for them. It seeks to provide the students with exposure to teaching skills and give them an opportunity to learn and imbibe the art of teaching.

The modalities of the policy are as follows:

- 1. Every teacher teaching an LLM course, if agrees, may be allotted four LLM students willing to learn teaching.
- 2. The various areas on which the teachers may train the students include the followings:
  - How to find and select relevant material for a particular lecture
  - How to structure and prepare a lecture
  - How to begin a lecture
  - How to answer or handle questions from students
  - How to create a learning environment in the class
  - How to ensure your reception by every student
  - How to have an interactive class and engage the students
  - How to keep calm
  - How to use PPTs
  - What not to speak in the class (misogynistic, patriarchal, sexist, casteist, hateful, half-truthful, communal, stereotypical, racial or very personal remarks must be avoided.)

- 3. After two weeks of such training, the teachers may ask the students to teach in their BALLB classes for a time duration mutually agreed upon.
- 4. Whenever the LLM students teach in BALLB classes, the respective teachers shall be present to oversee their performance.
- 5. The teachers may ask the LLM students to accompany them to their BALLB classes during their lectures without affecting the scheduled LLM classes of the students.
- 6. An LLM student shall not be asked to teach in BALLB for more than two times a month.
- 7. Teachers may introduce peer teaching and ask the students on regular basis to explain for 10-15 minutes in their own LLM class the topics already taught. Subsequently, the teachers may give their respective feedbacks.
- 8. The teaching by the students shall not be subject to any evaluation/ assessment in terms of marks or grade.
