ABOUT THE NLUJA

National Law University and Judicial Academy, Assam (NLUJAA), was established by the Government of Assam through the National Law School and Judicial Academy, Assam Act, 2009 (Assam Act No. XXV of 2009). The institution was renamed in 2011 through an amendment replacing "School" with "University." The Chief Justice of the Gauhati High Court, Hon'ble Mr. Justice Ashutosh Kumar, serves as its Chancellor.

NLUJAA offers modern legal education and research opportunities to students from diverse backgrounds across India, including the Northeast. With strong support from the Assam government, the university operates on a 50-acre campus in Amingaon, situated along the northern banks of the Brahmaputra River. It currently has around 300 students enrolled in its BA LLB (Hons), LLM, and PhD programs.

NLUJAA continues to evolve with a strong commitment to redefining legal education while actively shaping the legal landscape in India, particularly in the Northeast region. Through academic excellence, research initiatives, and engagement with contemporary legal challenges, the institution strives to foster a new generation of legal professionals equipped to drive meaningful change.



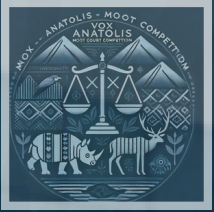
MESSAGE FROM THE FACULTY CONVENER

ABOUT VOX ANATOLIS MOOT

The Vox Anatolis Moot Court Competition ("The Voice of the East") organised by NLUJAA, uniquely focuses on legal issues pertinent to Northeast India. Designed to engage law students nationwide, it provides a platform to explore the region's legal complexities.

Previous editions have addressed significant legal and policy matters, including the National Register of Citizens and Biodiversity Laws of Assam, attracting widespread participation. Building upon the success of the first four editions, both regionally and nationally, we are pleased to introduce the fifth iteration of this moot in 2026.

With a vision to strengthen the mooting culture in Northeast India, this edition marks the beginning of a long-term initiative to promote legal scholarship in the region. By fostering engagement at both regional and national levels, Vox Anatolis aspires to serve as a leading forum for discourse on Northeast Indian legal issues, solidifying its reputation as the Voice of the East.

PREVIOUS EDITION

The National Law University and Judicial Academy, Assam hosted the prestigious 4th Vox Anatolis Moot Court Competition, which witnessed the participation of 80 teams, in collaboration with the Centre for Tribal Law, Policy and Justice, NLUJA, SCC Online, and SCC Times.

Open to all bona fide undergraduate law students from recognised institutions, the competition focused uniquely on legal issues pertinent to Northeast India, with its subject matter dedicated to highlighting the region's rich and complex socio-legal landscape and ensuring that its unique perspectives were acknowledged in broader legal discourse.

This esteemed inter-collegiate event brought together law students from diverse academic years and regions across the country and served as an invaluable platform to hone their advocacy skills, while rigorously testing their oratory abilities, analytical precision, and attention to detail, thereby fostering deeper legal expertise.

COMPETITION STRUCTURE



The Competition shall comprise two stages:

Memorandum Elimination Round: The results of this round shall be based on the evaluation of Memorandums and shall determine the 32 teams that will proceed to the Oral Rounds.

Oral Rounds: The teams that qualify the Memorandum Elimination Round shall be eligible to participate in the Oral Rounds, which shall comprise Preliminary Rounds and Advanced Rounds. The oral rounds shall be held virtually.



ELIGIBILITY & REGISTRATION

The Competition is open to students enrolled bona-fide on a regular basis in an Undergraduate/Postgraduate law course or its equivalent conducted by any institution recognized by the Bar Council of India.

There is no limit on the number of teams applying from one institution. Teams are required to make a payment of ₹3300 to confirm their participation in the competition. The consolidated link for all documents is mentioned as follows:

Teams of 2 or 3 are welcome to register. Once registration has been verified teams will be assigned a Team Code (" TC- XX") for identification for the duration of the Moot. Registrations close on 18th February, 2026.
