## Consultative Workshop on Framing of Legislation for Assam Inland Water Transport: A Report



National Law University and Judicial Academy, Assam in association with the Assam Inland Water Transport Development Society organised a one-day Consultative Workshop on Framing of Legislation for Assam Inland Water Transport, on August 21, 2017. The objective of the workshop was to deliberate upon the various aspects of inland water transport in the State of Assam, and to invite suggestions from government officials, resource persons and academicians with regard to the formulation of legislations for the regulation of inland water transport in the state.

The workshop was graced by Shri Vinod Kumar Pipersenia, Chief Secretary to the Government of Assam, Shri Ashutosh Agnihotri, Commissioner and Secretary to the Transport Department, Government of Assam, Shri Bharat Bhushan Dev Choudhury, Director, Inland Water Transport, Dr. Srinivas Chokkakula, Fellow, Centre for Policy Research, New Delhi and Prof. (Dr.) J.S. Patil, Vice-Chancellor, National Law University and Judicial Academy, Assam. It was also extremely fortunate to have Mr. Biju Oommen and Mr. Honey Gupta, officials of the World Bank, Prof. (Dr.) Chandan Mahanta from the Indian Institute of Technology, Guwahati and other key officials of Inland Water Transport Department, Assam.

The workshop had three technical sessions which included presentations by in-house team of researchers lead by Mr. Chiradeep Basak, Assistant Professor of Law, National Law University and Judicial Academy, Assam and an open-house discussion at the end of each presentation.





The three technical sessions covered the economic paradigms relating to inland waterways and transport in Assam, the environmental and safety concerns which need to be taken into consideration along with discussions on the drafting of a Memorandum of Association and an Article of Association for the companies to be incorporated to regulate ports and vessels for inland water transport. The sessions focused on the costs associated with inland waterways, the various existing legislations dealing with the regulation of ports, vessels and inland water transport in India as well as the guidelines on boat safety designed by the National Disaster Management Authority. Reference was also made to the good practices adopted by other countries with flourishing inland water transport systems, such as Germany, China, Brazil and Bangladesh.

The researchers emphasized on the importance for inclusion in the draft legislation, measures for the protection and preservation of endangered species inhabiting the river Brahmaputra. The researchers further drew attention to the fact that for the formulation of a legislation which takes into consideration the interests of all the stakeholders, coordination among the various departments of the Government of Assam is the prerequisite along with capacity-building and awareness programmes for training and skill-development of stakeholders. The session ended with valuable suggestions from the officials of the Inland Water Transport Department as regards the training of the crewmembers and the regulation of vessels for personal use. Suggestions also flew in with respect to technical aspects related to the river Brahmaputra, such as the nutrient content, frequent flood situation as well as the concerns as regards dredging activities.

## Visit of Sri (Dr.) Himanta Biswa Sarma, Hon'ble Finance and Education Minister, Government of Assam: A Report

#### August 25, 2017:

Shri (Dr.) Himanta Biswa Sarma, Hon'ble Finance and Education Minister, Government of Assam visited the National Law University and Judicial Academy, Assam on August 25, 2017. Upon his arrival, the Hon'ble Minister had an earnest discussion with the Vice-Chancellor regarding the vision and the strategies to be adopted towards the development of the University. He conducted a tour of the campus to assess the capacity of the University as also of the imminent deficits and needs. He addressed the students and held an interactive session with them. His charismatic speech and incisive insights enthralled the students, faculty members and administrative staff who participated in the session. He addressed the issue of equal access to Justice for the common people who are always in a disadvantageous position.





He also appealed to the academicians from the University to collaborate with the Gauhati High Court in reducing number of pending cases through projects, internship etc. He urged that NLUJAA should have its own ideology and take inspiration from India's ancient education systems like Takshashila and Nalanda. The Hon'ble Minister assured the University of financial assistance for 300 bedded hostel, a playground and plantation of more trees in the campus. The visit opened up opportunities of strengthening the ties between NLUJAA and the Govt. of Assam and of forging collaborations with the Govt. of Assam, which would enable the university to stand in good stead.

The Conference invited papers from research scholars, academicians, students, civil society organisation, writers/editors and child protection practitioners (advocates/activist) from across the country to present paper under the following themes:

- Supporting parents, care givers and families
- ii. Helping children and adolescent manage risk and challenges
- iii. Changing attitude and social norm that encourage violence and discrimination
- iv. Promoting and providing support services for children
- v. Implementing laws and policies that protect children
- vi. Carrying out data collection and research



The conference saw participation from various states like Rajasthan, Karnataka, Bihar, Uttar Pradesh, Delhi, Punjab, Haryana, Meghalaya, Assam, Tripura, Mizoram, Arunachal Pradesh, Nagaland, Manipur and Sikkim. The occasion was graced by the Hon'ble Vice Chancellor, Prof. (Dr.) J.S. Patil of National Law University and Judicial Academy, Assam and by Mr. Vedprakash Gautam, Child Protection Specialist, UNICEF, Officer for Assam.

The two-day deliberation brought together intellectuals to deliberate on the issue of violence against children in North Eastern States and Sikkim. The conference also brought forth important recommendations by presenters to exhort the stakeholders and important players to adopt steps to combat such violence against children.

The main agenda of the Legal Aid Camp was to make the audience aware of their rights and duties by way of presentations and skits being performed by the students of National



Law University and Judicial Academy, Assam. In pursuance of the agenda the students of ninth semester spoke on various legal issues like: (i) Fundamental Rights of Indian Citizens and non-citizens - presented by Debayan Banerjee; (ii) Public Interest Litigation - presented by Abhishek Dhar Karmakar; (iii) Legal Aid and Its Mechanisms under Legal Services Authorities Act, 1987- presented by Ipshita Bhattacharya. Students of National Law University and Judicial Academy, Assam also performed skits on Consumer Protection and Domestic Violence. ## Orientation Programme for Jt. Directors of Health Services, Superintendent of District Hospitals and DPMs, on Child Sexual Abuse (CSA)

#### November 25, 2017:

Centre for Child Rights in association with National Health Mission (NHM) had organised a day long programme with District Programme Managers, Jt. Directors of Health Services and Superintendents of Govt. Hospitals from all 9 lower Assam districts (Barpeta, Bongaigaon, Chirang, Dhubri, Goalpara, Nalbari, Kamrup Metro, Kamrup Rural and Kokrajhar) on 25th November, 2017. The programme was organised with the aim to:



- 1. Create awareness and sensitize the examining doctors at the district level about the legal aspects, roles and their responsibilities and
- 2. Coordinate with NHM and Dept. of Health and Family Welfare to adopt and notify 'Medico Legal Format' for victims of rape and sexual assault as prescribed in the POCSO guidelines of 2014, to strengthen the prosecution process and conviction of POCSO cases.

In the training programme there were around 30 participants and representatives from the Department. Centre for Child Rights had invited Mr. Surendra Kumar, IPS, Inspector General of Police, CID Assam, Dr. Richa Pandey, Associate Professor, Forensic Medicine, JMCH, Mr. Manjit Das, Advocate – Human Rights Law Network, Assam and Dr. C. Ravichandran, Health Specialist, UNICEF North East to highlight the issues of increasing sexual crimes against children, the role of doctors and the importance of medico legal format during the legal procedure.

The programme generated the need for a Standardized Medical Format for victims of sexual abuse and laid down recommendation and suggestions on the format. It also highlighted good practices adopted by hospitals in treating victims of sexual abuse.

## Free Health Check-up Camp at NLUJAA Health Centre

#### November 27, 2017:

A health camp, sponsored by FHPL, was organised at Health Centre of NLUJAA on Nov. 27, 2017 for the faculty and non-teaching staff members of NLUJAA. The main purpose was to maintain proper health of the University staff. Free general health checkup, R. B.S testing, B.P. test, E.C.G tests were provided. They were directed for TSH, eye checkup as required. Total number of beneficiaries of the free health check-up were 43.

## **Residential Training Workshop for Child Welfare Committee (CWC)**

#### December 18-22, 2017:

At the request of the Department of Social Welfare, Centre for Child rights in partnership with State Child Protection Society and with technical assistance from TISS, Guwahati, prepared a 5 days comprehensive training module for Child Welfare Committee and had organised a training programme from 18th to 22nd December, 2017 with the first batch to pilot the module.

The programme invited a total of 30 participants who are Members and Chairperson of CWC from various districts of Assam. The training programme focused at sharpening the understanding of participants towards appreciating psychosocial concerns and issues of children who are vulnerable, understand macro issues that shape such issues and work towards developing skills in relation to analysis as well as in relation to Communication. It was designed with an objective to –

- 1. To enhance conscientisation of value base (warmth, empathy, Confidentiality and genuineness) when dealing with issues related to children.
- 2. To impart understanding of CWC members on psychosocial issues related to Children through an appreciation of theoretical frameworks.
- 3. To impart an understanding of structural and macro issues that leads to vulnerability of children and enhance analytical skills.



- 4. To develop skills and competencies in relation to Communication with Children encourage child participation using child friendly approach.
- 5. To orient them on other legislations pertaining to children, viz. Child Labour (Prohibition and Regulation) Amendment Act, Protection of Children from Sexual Offences, Act, Prevention of Child Marriage Act, provisions of Criminal Law Amendment Act pertaining to Children, etc.

The training programme received recommendation and suggestion on the learning requirement of the members of the Child Welfare Committee and paved the way for developing a certificate course for the Members and Chairpersons of the CWC in the state of Assam.
