UNDP-GEF, National Biodiversity Authority, NLSIU and NLUJAA research project on strengthening human resources, legal frameworks, and institutional capacities to implement The Nagoya Protocol

February 12-16,2018

The UNDP-GEF Project: Strengthening human resources, legal frameworks, and institutional capacities to implement the Nagoya Protocol is a three-year project that specifically aims at assisting countries in the development and strengthening of their national ABS frameworks, human resources, and administrative capabilities to implement the Nagoya Protocol on Access and Benefit Sharing. The project seeks to achieve this by a) strengthening the legal, policy and institutional capacity to develop the ABS Frameworks, b) building trust between users and providers of genetic resources to facilitate the identification of bio-diversity efforts: and c) Strengthening the capacity of indigenous and local communities to contribute to the implementation of the Nagoya Protocol.

The implementation of the basic measures of the Nagoya Protocol in the participating countries is intended to unleash a wide range of monetary and non- monetary benefits for providers of genetic resources. Some of these benefits should be reinvested in the conservation and sustainable use of the biological resources from where the genetic resources were obtained. This will help in fulfilling one of the three objectives of the Convention of Biological Diversity. i.e. the fair and equitable sharing of the benefits arising out of the utilization of genetic resources, including access to genetic resources, transfer of relevant technologies and

funding. The first phase of the project involved conducting Inception and Training the Trainers workshop aimed at training law professors/teachers and key persons from the industry in the undamentals of the Biological Diversity Act, the Convention on Biological Diversity and the Nagoya Protocol on Access and Benefit Sharing and other legal and policy aspects affecting biological diversity and the ABS mechanism in India. This workshop was successfully carried out from the 12th to 16th February 2018 by the National Law School of India University on its campus.



Mr. Chiradeep Basak, Assistant Professor of Law was nominated for the said Master Trainer's program. His project proposal to pursue an action research has also been selected. The said action research will be carried out by Centre for Environmental Law, National Law University and Judicial Academy, Assam under the coordinator-ship of Mr. Basak. A two-day regional workshop will be organized at NLUJAA in 2018 for the same.

# Proceedings of the First Convocation of National Law University and Judicial Academy, Assam

February 25, 2018

The First Convocation of the National Law University and Judicial Academy (NLUJA), Assam was held in a grand manner with several distinguished personalities gracing the Ceremony. A number of dignitaries including Hon'ble judges of the Gauhati High Court, judicial officers, distinguished invitees, Government officers, members of the General Council, Executive Council, Academic Council and other statutory bodies of the University took part in the Ceremony held on the 25th of February 2018 at the NLUJAA





campus in Amingaon, Guwahati. Shri Sarbananda Sonowal, Hon'ble Chief Minister of Assam was invited on the occasion to be the Distinguished Guest. The Hon'ble Chief Minister sent his best wishes since due to some unavoidable reasons he was unable to attend the Convocation Ceremony. The ceremony began at 10:58 am with the arrival of the Academic Procession at the venue where the graduands were already waiting. The Academic Procession was led by the Registrar of the University, Mr. Miftahuddin Ahmed, ACS. The Procession comprised of the honorable members of the General Council, Executive Council, Academic Council and the distinguished guests. After the

members entered the venue the National Anthem was sung. Then the Registrar of the University requested the Hon'ble Chancellor to declare the Ceremony open. The Chancellor formally declared the opening of the Convocation Ceremony which was followed by the Welcome Address and Presentation of the University Report by the Vice-Chancellor.

In his address, the Vice-Chancellor, welcomed everyone and extended his greetings on the first convocation of the National Law University Assam. The Vice-Chancellor welcomed Hon'ble Mr. Justice J. Chelameswar, Judge, Supreme Court of India. He expressed his gratitude while recalling the Hon'ble Mr. Justice J. Chelameswar's unstinted support and commitment to the development of this University and said that the University was blessed to have him as the Chief Guest to deliver the first convocation address.



The Vice-Chancellor also extended a warm welcome to Hon'ble Mr. Justice Ranjan Gogoi, Judge, Supreme Court of India who was a Guest of Honour and addressed Hon'ble Mr. Justice Ranjan Gogoi as a 'son of the soil' and expressed hope that his continued support would help in building NLUJAA as a prominent University. The Vice-Chancellor also welcomed Hon'ble Mr. Justice Arvind Bobde, Judge, Supreme Court of India whom he described as a great personality known to Indian Judiciary and acknowledged Hon'ble Mr. Justice Arvind Bobde's keen interest in the overall growth of NLUJAA. The Vice-Chancellor extended a warm welcome to the Chancellor of NLUJAA, Hon'ble Mr. Justice Ajit Singh, Chief Justice of Gauhati High Court, and expressed his gratitude for the continuous guidance and his commitment to the development of the University which was unparalleled.

The Hon'ble Vice-Chancellor presented the University Report called the "Journey So Far" of NLUJAA before the august gathering. The Vice-Chancellor recalled the commencement of the University. The National Law University and Judicial Academy, Assam (NLUJAA) has been established by the Government of Assam by way of enactment of the National Law School and Judicial Academy, Assam Act, 2009 (Assam Act No. XXV of 2009). The word 'School' was replaced by the word 'University' by amending the National Law School and Judicial Academy, Assam (Amendment) Act, 2011. Classes began from a small three room apartment in Uzan Bazar near the Gauhati High Court, Guwahati. Three months later, the University was shifted to the North Eastern Judicial Officers' Training Institute (NEJOTI) building at Ulubari, Guwahati.

The first academic session started functioning from September 1, 2011 with the first batch of sixty students of B.A.LL.B. Honours. The foundation stone for the Permanent Campus of the University at Amingaon was laid by Hon'ble Shri Justice Adarsh Kumar Goel, the then Chief Justice of the Gauhati High Court and the Chancellor of the University on July 1, 2012. The permanent Campus is situated in a sprawling 60 acres of beautiful landscape with sylvan hills in the backdrop and the mighty Brahmaputra River flowing in the frontage was inaugurated on March 25, 2017 in the presence of a galaxy of distinguished guests.

The Vice-Chancellor acknowledged the continuous monitoring and support by His Lordship, the Chief Justice of Gauhati High Court who held fortnightly campus review meetings along with the Chief Secretary of Government of Assam and a team of dedicated Hon'ble Judges of Gauhati High Court, Judicial Officers, Government Officers, PWD Engineers and the teaching and non-teaching staff for the growth of the campus with state-of-the-art facilities. A few milestones achieved by the University were presented before the audience. On December 7, 2016, NLUJAA became a member of the Shastri Indo-Canadian Institute (SICI) paving the way for collaborations and exchange programmes with the Canadian Universities. A Ph.D. student of NLUJAA was awarded a fellowship to research for three months in Canada. The Vice- Chancellor also placed on record his visit to Soochow University Law School, Taipei in order to explore collaborations with important universities in China and Japan at their invitation on November 24-26, 2017. Efforts are on to develop collaborations with the European Universities and Universities in the U.S. The University has entered into MoUs with the Assam Administrative Staff College on April 27, 2017, the India International Institute of Democracy and Election Management (IIIDEM), Election Commission of India, New Delhi on April 27, 2017 and IDIA Charitable Trust on May 15, 2017. The University has also established the Centre for Child Rights in collaboration with the UNICEF to study, research and promote child rights activities in Assam and the North-East. The Centre for Environment Law and the Centre for Disability Rights and Mental Health Laws were also established and functioning effectively. The University is handling a Government of Assam project funded by the World Bank for drafting of the legislation for the establishment of Inland Water Transport Regulatory Authority and Memorandum of Association and Articles of Association for the establishment of two companies to manage ports and vessels. The University has started the Dr. Gurjeet Singh Memorial National Moot Court Competition from the academic year 2016-17 as a flagship programme of the University. "Adhwik Udjjapon" ADUJ 2017, a national cultural fest for students was also successfully conducted in the same year. The University is publishing two journals NLUA Law and Policy Review and NLUA Law Review (Student Journal). The University also publishes a six-monthly news magazine called Nyayalok. A project on "Minimum Laws" to research and systematize laws of the State of Assam is under preparation and will soon be taken up. The initiative is taken by the Chief Secretary of the Government of Assam to institute Chief Minister's Good Governance Fellowships where under the students of NLUJAA will be posted in the Government Departments to understand their working and suggest innovations in the system. As desired by the Hon'ble Chief Minister, efforts are on to establish a Centre for Space Law Research with the assistance of ISRO which is being facilitated by Kamath & Kamath, Bangalore.

The Vice-Chancellor also stated that the faculty members are actively engaged in quality teaching, research, extension and other co-curricular activities, participating in national and international seminars and conferences. The students have been participating in national and international conferences and Moot Court Competitions and have brought many laurels to the University. The University has plans to establish a few more study and research centres, launch part time LL.M. degree programme for legal professionals and start some diploma and certificate courses in cutting edge areas of law. Preparatory work is going on in developing necessary regulations for these programmes.

The Vice-Chancellor concluded his speech with a note that in the last seven years of its establishment the University has managed to carve a niche for itself in the highly competitive world of legal academics and



expressed his hopes that this institution shall develop as an eminent University of national and international repute in the coming years with the kind cooperation of everyone present. Then the Presentation of the Degrees and Medals commenced with the bestowing of the Degree by the Hon'ble Chancellor, Mr. Justice Ajit Singh, Chief Justice, Gauhati High Court. Altogether 148 Graduands of B.A., LL.B. and LL.M were given their degrees, the details of which are furnished below,

The Convocation Address was delivered by the Hon'ble Mr. Justice J. Chelameswar, Judge, Supreme Court of India who was the Chief Guest on the occasion. Hon'ble Mr. Justice J. Chelameswar began his speech by expressing his happiness at being associated with this University since its



establishment. He recalled that Thomas Jefferson, President of the United States wanted to be known as the author of the American Declaration of Independence and founder of Virginia University rather than as the President of the United States—association with educational institutes brings honour and recognition to those who understand the value of education. He stated that legal history of mankind has been a conflict





between individuals' liberty and state's efforts to curtail that liberty and that the State has to establish "just order" social but the understanding of it changes with time and space. Two things emerge from such conflict—establishment organised State and Law. requirement of law is for regulating conduct of rulers and subjects. Human experience shows that power tends to destroy liberty and excesses of power must be regulated. This led to invention of concept of governance by the Constitution.

The Constitution is designed to establish fundamental norms of the government and limitation on power to make laws. Hon'ble Mr. Justice J. Chelameswar also reminded the audience that the Constitution is made by human beings and that the State exists for welfare of the people not vice versa. Securing liberties of people is only possible when the institutions established for upholding constitution are strong, vibrant and committed to the values of the Constitution. And that Constitutional history shows that it is a saga of sacrifice. According to Lawrence Tribe, "a constitution is a document written in human blood". The Hon'ble Mr. Justice also urged upon the students to be mindful of the fact that as future lawyers, lawmakers, judges they would have to make a choice between achieving personal success and having it tempered with a noble goal. He concluded his speech by quoting John F. Kennedy who mentioned about Theodore Roosevelt in some context, 'Credit goes to that man whose face is marred by the sweat, the dust and the scars of the battle—if he succeeds he knows the high achievement, if he fails he fails so daringly that his place shall never be with those cold and timid souls who know neither victory nor defeat'.

Hon'ble Mr. Justice Ranjan Gogoi, Judge, Supreme Court of India and Hon'ble Mr. Justice Arvind Bobde, Judge, Supreme Court of India who were the distinguished Guests of Honour also addressed the students' community and the graduating students. In his speech, Hon'ble Mr. Justice Arvind Bobde, Judge, Supreme Court of India, gave a valuable insight into the life of an individual who is shaped by adversity and resilience by sharing an anecdote. He also urged the students to be aware that they would be assisted by technology to a large extent and they should arm themselves with adequate knowledge and exert themselves well. Hon'ble Mr. Justice Ranjan Gogoi, Judge, Supreme Court of India, mentioned in his address that it gave him immense pride to be associated with the first National Law University in the North East. He expressed his satisfaction that the University is offering to the country dedicated and motivated individuals who have undergone a transition from being unassuming under graduate students to insightful Law graduates, from being 'Dreamers' to 'Doers'. The Hon'ble Mr. Justice Ranjan Gogoi reminded the students, 'the social engineers' to inculcate personal integrity which is dwindling across institutions and across ideologies. He urged them to find their moral compass and be governed by it and defend the truth wherever they go since they are the harbingers of the new order, new ambitions, new aspirations and values. The Hon'ble Mr. Justice concluded his address by asking them to "Be the change that you wish to see in the world".

The Convocation was declared closed by the Hon'ble Chancellor and the hall rose for the National Anthem. The Ceremony came to a close after the Academic Procession left the Convocation Hall.



#### Visit of Prof. Armin Rosencranz, Lawyer and Political Scientist to NLUJAA

March 10, 2018

On 10th of March 2018, Professor Armin Rosencranz delivered a 2 hour discourse to students of NLUJA, Assam on the topic 'Climate change, Energy and Equity'. Armin Rosencranz is a lawyer and political scientist (AB, Princeton; JD, MA, PhD Stanford). He has taught at Berkeley (1987-94) and Stanford (1994-2012). He founded and led an international environmental NGO, Pacific Environment (1987-96). With all the talks on climate change today, with nations realising the need to combat climate change and re-strategize on energy



consumption methods, he elucidated upon how a very ambitious renewable energy plan/strategy by states may lead to consequential effects on the non-renewable energy sources of the planet, and also stated that the United States and India have taken regressive steps on climate change. Today, with renewable energy in the market equivalent to the cost of fossil fuels, he emphasised on how countries around the globe are trying to better utilise the renewable sources available- such as solar, hydro, wind, geothermal and nuclear energy. This recent change can be a tipping point that may make fighting climate change profitable for energy companies.

In relation to each of these, he elaborated on how each energy source can be and is being put to use for generation of energy in the most efficacious way, with the least amount waste generation. Taking India as an example, he related to how making use of the abundance of solar energy by way of installing rooftop solar panels or photovoltaic cells can help the large population residing in the rural areas, inaccessible to electricity avail the luxury of light.

Nuclear power, to be precise, nuclear fusion, considered 'the future of clean energy' if rightly put to use, can revolutionise energy supply. There, however exists differing views amongst the world community on how its usage can lead to more harm or more good. Issues relating to the vulnerability of the nature of nuclear power, generation of nuclear waste, and safety measures are constantly being debated. Professor Rosencranz threw light on how the world would benefit and lay all questions to rest if the possibility of having a single nuclear reactor can be made true.

Climate change is primarily because of excessive carbon in the atmosphere; this overload is because of a number of reasons- burning fossil fuels, large scale deforestation including burning of forests for cultivation purposes, etc. With developing countries undertaking operations of cutting down their tropical forest lands for trade, (export) and, for reasons such as to habitat their increasing population, stored carbon is released to the atmosphere, contributing to the already carbon-overload in the atmosphere. Soil is another carbon-rich component, which when ploughed for cultivation (agricultural purposes) releases a massive amount of carbon. Solutions to prevent and control such operations include processes such as-

- 1) Carbon capture and storage- a process of capturing and storing carbon below the ground so that it does not enter the atmosphere.
- 2) Conservation tillage- a method of soil cultivation which is a system that would conserve soil by improving methods of plating, growing and harvesting of crops with as less erosion of the top soil as possible.

Other strategies that can be followed to control carbon output such as levying carbon tax, having regulations such as Renewable Portfolio Standard (RPS), utilisation of geo-thermal energy, adopting methods that would prevent huge energy loss during transmission were also discussed.

Other highlights included discussion on principles of equity in sustainable development, with emphasis on understanding intergenerational equity as well as intra-generational equity. Some core principles that were discussed included the Neighbour's Principle, the Polluter Pays Principle, and the Precautionary Principle. The entire discourse was replete with case laws and judicial analysis, more so in the discussion of The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act passed by the Indian Parliament in 2006. Two important cases- The Vedanta case (*Orissa Mining Corporation v. Union of India and Ors.* (2013) 6 SCC 476) and *T.N. Godavarman Thirumulkpad v. Union of India were* crucial with regards to the aforementioned legislation. The latter case being particularly related to the North Eastern region of India, wherein, a large number of wood-based industries of the region were affected as a reason of the Hon'ble Court's judgment. The Supreme Court of India developed what is known as a 'continuing mandamus' in this case- which Professor Rosencranz mentioned that it is a concept peculiar to Indian judiciary. The discussion ended with Professor Rosencranz answering questions from the enlightened audience.
