- 1. Guest/Adjunct Faculty Member of Law (with specialization in Business Law) and Economics.
- 2. Research Assistant / Research Associate of Law (with specialization in Disability Studies).
- I. Qualification for Guest / Adjunct Faculty Member of Law and Economics:
 - A. i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
 - ii) Besides fulfilling the above qualifications, it is desirable that the candidate shall have cleared the National Eligibility Test (NET) conducted by the UGC or a similar test accredited by the UGC, like SLET/SET. Candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2018 and theiramendments from time to time, may be exempted from NET/SLET/SET:

Provided that, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at leastone is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for whichNET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

B. The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non- creamy Layer)/Differently abled (a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acidattack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness;

(e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifyingmarks without including any grace mark procedure.

II. Qualification for Research Assistant and Research Associate:

Candidates with LL.M. /M.A./Master's Degree in the relevant subject with not less than 55% marks in the aggregate from a recognized University.

Pay: (a) Rs. 25,000/- (Consolidated) per month for the Research Assistant

(b) Rs. 30,000/- (Consolidated) per month for the Research Associate

Note: 1. Shortlisted candidates will be empaneled for a period of one semester and will be called upon in order of merit as and when required by the University. Appointment, if at all, shall be made per semester.
