3. Sample of cloth (minimum 1/2 mtr.) need to be submitted with the quotation. Delivery of items should be completed within 15 (fifteen) days after receipt of supply order.
4. Quoted rates for Shirt, Pant, Saree & Blouse and coats should be inclusive of stitching charges.
5. Bidders must quote price against all items.
6. The Quotationer/Tenderer will have to deposit Earnest Money of **Rs. 5,000/-** in the form of Demand Draft in favour of Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of work.

7. Each Firm/Individual/Tailor must submit GST Registration Certificate, Trade License, PAN Card, Income Tax Clearance Certificate. A copy of the same must be submitted along with the Quotation/Tender.
8. Bills must be submitted along with necessary work order and a copy of Challan etc. within seven days of the date of delivery of items, for payment. Failing which no payment shall be made.
9. Any Firm/Individual/Tailor indulging in malpractice or adopting any unfair means will be barred from working with the University.
10. Past records of the Firms/Individuals/Tailors will be duly considered while awarding the work.
11. Quality of samples along with price quoted will be considered in the screening process.
12. The vendors should have a/an outlet/functional operational unit at Kamrup/Kamrup (M).
13. Any other condition deemed to be just, fit and proper during selection process, may be imposed by the University.
14. The University reserves the right to accept/reject any or all the quotations in full or part at its discretion without assigning any reason thereof and decision of the NLUJA, Assam in this regard shall be final.
