- 5. Quoted rate for Shirt, Pant, Saree and Blouse should be inclusive of stitching charges.
- 6. The Quotationer/Tenderer will have to deposit Earnest Money of Rs. 5,000/- in the form of Demand Draft favouring Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of work.
